1	AN ACT relating to the investigation of a shooting or deadly incident by a law
2	enforcement officer.
3	Be it enacted by the General Assembly of the Commonwealth of Kentucky:
4	→SECTION 1. A NEW SECTION OF KRS CHAPTER 15A IS CREATED TO
5	READ AS FOLLOWS:
6	As used in Sections 1 to 5 of this Act:
7	(1) "Deadly incident" means a shooting by a law enforcement officer that results in
8	the death of another individual or any incident that results in the death of an
9	individual while in the custody of law enforcement or while being questioned or
10	actively pursued by law enforcement;
11	(2) "Employing law enforcement agency" means the law enforcement agency that
12	employs any law enforcement officer or officers involved in a shooting of an
13	individual or a deadly incident;
14	(3) 'Kentucky State Police Critical Incident Response Team' means a unit of the
15	Kentucky State Police responsible for investigating a shooting of an individual by
16	a law enforcement officer or officers or a deadly incident;
17	(4) "Officer Shooting Review Board" or "board" means the board established in
18	Section 2 of this Act that is authorized to investigate the shooting of an individual
19	by a law enforcement officer or officers or a deadly incident; and
20	(5) "Primary investigation" means the investigation conducted by the board.
21	→ SECTION 2. A NEW SECTION OF KRS CHAPTER 15A IS CREATED TO
22	READ AS FOLLOWS:
23	(1) The Officer Shooting Review Board is hereby established and administratively
24	attached to the Office of the Attorney General. The board shall investigate any
25	shooting of an individual by a law enforcement officer or officers and any deadly
26	incident. Notwithstanding any statute to the contrary, employing law enforcement
27	agencies shall be prohibited from conducting a criminal investigation into the

1		shooting or incident until the conclusion of the board's investigation as outlined
2		in Section 5 of this Act.
3	<u>(2)</u>	The board shall consist of seven (7) members appointed by the Attorney General
4		for a term of four (4) years and shall include:
5		(a) A liaison from the Justice and Public Safety Cabinet;
6		(b) A retired judge who has served as a District Court or Circuit Court Judge
7		within the Commonwealth for at least ten (10) years;
8		(c) A retired chief of police, sheriff, assistant chief of police, or deputy sheriff
9		from any county or municipality within the Commonwealth of Kentucky;
10		(d) An assistant deputy Attorney General;
11		(e) A professor or researcher affiliated with a Kentucky university or college
12		who has expertise in the field of criminal law or criminal justice;
13		(f) A representative of a nonprofit organization whose mission is focused on
14		social justice or civil rights advocacy;
15		(g) A former Commonwealth's attorney or assistant Commonwealth's attorney
16		who served in that capacity for at least five (5) years; and
17		(h) A private criminal defense attorney or a former public defender who served
18		in that capacity for at least five (5) years.
19	<u>(3)</u>	The board shall meet as necessary to perform its duties as established under
20		Sections 1 to 5 of this Act.
21	<u>(4)</u>	If any member of the board is currently employed or has been employed by the
22		agency employing any law enforcement officer who is subject to a current
23		investigation, the member shall recuse himself or herself from the investigation.
24	<u>(5)</u>	Any vacancy that may occur in the membership of the board shall be filled by the
25		Attorney General.
26	<u>(6)</u>	The members of the board shall serve without compensation but shall be
27		reimbursed for necessary travel expenses.

1		→ SECTION 3. A NEW SECTION OF KRS CHAPTER 15A IS CREATED TO
2	REA	AD AS FOLLOWS:
3	<u>(1)</u>	Except as provided in subsection (2) of this section, the Kentucky State Police
4		Critical Incident Response Team shall be responsible for the initial investigation
5		of a shooting of an individual by a law enforcement officer or officers or a deadly
6		incident under investigation by the board.
7	<u>(2)</u>	If a shooting of an individual by a law enforcement officer or officers or a deadly
8		incident involves one (1) or more Kentucky State Police officers, then the law
9		enforcement agency with jurisdiction over the location of the shooting or deadly
10		incident shall be responsible for the initial investigation.
11	<u>(3)</u>	The Kentucky State Police Critical Incident Response Team shall establish a
12		written policy for handling any investigation of a shooting of an individual by a
13		law enforcement officer or officers or a deadly incident. The policy shall:
14		(a) Be subject to approval by the board; and
15		(b) Include evidence-based policies.
16		A copy of the approved policy shall be filed with the Kentucky Law Enforcement
17		Council established in KRS 15.315 and made available to the public pursuant to
18		KRS 61.870 to 61.884.
19	<u>(4)</u>	If the shooting of an individual by an officer or officers or a deadly incident is
20		traffic-related, the policies of the response team and all consenting authorized
21		law enforcement agencies shall require the investigative team to use a crash
22		reconstruction unit from an agency that does not employ a law enforcement
23		officer involved in the death being investigated. The policy shall give preference
24		to using a unit from the Kentucky State Police.
25		→ SECTION 4. A NEW SECTION OF KRS CHAPTER 15A IS CREATED TO
26	REA	AD AS FOLLOWS:
27	<i>(1)</i>	Following any shooting of an individual by a law enforcement officer or officers

1		or any deadly incident within the Commonwealth, the following protocol shall be
2		implemented:
3		(a) The initial investigation shall be conducted by the Kentucky State Police
4		Critical Incident Response Team or other law enforcement agency as
5		provided in Section 3 of this Act or in subsections (5) and (6) of this section;
6		(b) The primary investigation shall be overseen by the board; and
7		(c) The board shall provide its final conclusion and recommendations to the
8		Commonwealth's attorney of the jurisdiction in which the shooting of an
9		individual by a law enforcement officer or officers or deadly incident took
10		<u>place.</u>
11	<u>(2)</u>	While conducting the initial investigation, the Kentucky State Police Critical
12		Incident Response Team or any authorized law enforcement agency may perform
13		all investigative protocols or procedures identified within the scope of the written
14		policy established under Section 3 of this Act.
15	<u>(3)</u>	Regardless of whether a policy or procedure is identified in the written policy, the
16		response team or authorized law enforcement agency shall perform the following
17		if necessary to the investigation:
18		(a) Acquire and preserve the original body camera files for all law enforcement
19		officers who were present at the scene at the time of a shooting of an
20		individual by an officer or officers or deadly incident;
21		(b) Secure all of the officers' vehicles and all items therein;
22		(c) Secure the involved weapons;
23		(d) Acquire and secure all video and audio files from all sources that could
24		potentially have evidence related to the incident in question;
25		(e) Administer drug and alcohol testing to all officers present at the time of the
26		shooting or the deadly incident;
27		(f) Map and photograph the scene;

1		(g) Obtain statements and contact information for all witnesses; and
2		(h) Gather, log, and secure evidence.
3	<u>(4)</u>	These procedures and protocols shall be performed as part of the initial
4		investigation, unless the response team determines either that it is impossible to
5		do so or that doing so would pose an extraordinary burden as explained in
6		writing by the Kentucky State Police Critical Incident Response Team.
7	<u>(5)</u>	During the course of the initial investigation, the response team may assign a
8		consenting authorized law enforcement agency to assist with the initial
9		investigation, if the following conditions are present:
10		(a) The response team reasonably believes that it is unable to respond to the
11		scene of the shooting or the deadly incident in a timely manner to
12		adequately perform initial investigative tasks; and
13		(b) The response team reasonably believes that it lacks adequate personnel to
14		exclusively perform the initial investigation.
15		Each consenting authorized law enforcement agency shall implement a written
16		policy identical to the written policy required in Section 3 of this Act. Each policy
17		is subject to the review and approval of the board.
18	<u>(6)</u>	Upon conclusion of the initial investigation, the materials gathered pursuant to
19		this section by the Kentucky State Police Critical Response Team or any
20		consenting law enforcement agencies shall be submitted to the board, unless
21		requested earlier by the board.
22	<u>(7)</u>	The board shall review the materials from the initial investigation and shall be
23		provided an investigative report by the Kentucky State Police Critical Response
24		Team or any consenting law enforcement agencies. When the board receives a
25		report from the response team, it shall review the report and evidence to
26		determine if it addresses all aspects of the incident in question. The board may
27		request more information, clarification, or testimony from members of the law

1		enforcement agency that prepared the report or otherwise participated in the
2		initial investigation.
3	<u>(8)</u>	The board may appoint an independent investigator to oversee the investigation
4		or may request that additional investigation work be done by the response team,
5		in which case the response team shall make a good-faith effort to comply with the
6		board's request in a timely manner.
7	<u>(9)</u>	Upon the conclusion of the investigation, the board shall submit a report to the
8		Commonwealth's attorney of the jurisdiction in which the shooting of an
9		individual or the deadly incident being investigated occurred. The report shall
10		include the board's investigatory conclusions and the opinion of each board
11		member as to whether the officer's or officers' actions were justified in the
12		shooting of the individual or the deadly incident.
13	<u>(10)</u>	If after reviewing the report provided by the board, the Commonwealth's attorney
14		of the jurisdiction in which the shooting of an individual by a law enforcement
15		officer or officers or a deadly incident took place declines to prosecute the law
16		enforcement officer or officers involved, the Attorney General may make a
17		determination to prosecute the officer or officers involved in the shooting or the
18		deadly incident.
19	<u>(11)</u>	Upon conclusion of the board's investigation and submission of the report to the
20		Commonwealth's attorney, the Attorney General shall release the report and any
21		accompanying files, excluding any information contained in the report and files
22		that are kept confidential pursuant to KRS 61.870 to 61.884.
23		→SECTION 5. A NEW SECTION OF KRS CHAPTER 15A IS CREATED TO
24	REA	D AS FOLLOWS:
25	An e	mploying law enforcement agency shall not initiate its internal investigation into
26	the s	hooting of an individual by a law enforcement officer or officers or a deadly
27	incid	ent until all of the following have been completed:

1	<u>(1)</u>	Written confirmation from the response team that its initial investigation is
2		complete;
3	<u>(2)</u>	Publication of the response team's investigative conclusions; and
4	<u>(3)</u>	The conclusion of the criminal prosecution investigation, which shall be
5		established by written confirmation from the Commonwealth's attorney of the
6		jurisdiction in which the shooting of an individual by a law enforcement officer
7		or officers or deadly incident took place or from the Attorney General if the
8		Commonwealth's attorney declines to prosecute.
