1 AN ACT relating to airports.

## 2 Be it enacted by the General Assembly of the Commonwealth of Kentucky:

- 3 → Section 1. KRS 183.090 is amended to read as follows:
- 4 (1) The cabinet shall cause all *general aviation* airport facilities in the state to be
- 5 inspected to determine the safety and adequacy of such facilities. No person shall
- operate any aircraft from <u>a general aviation [an]</u> airport declared unfit by the
- 7 cabinet.
- 8 (2) In determining whether it shall issue a certificate of approval [or license] for the use
- 9 or operation of *a general aviation*[any] airport, the cabinet shall take into
- 10 consideration its location, size, layout, safety of operations, the relationship of the
- airport to a comprehensive plan for statewide and nationwide development, whether
- the adjoining area is free from obstructions based on a proper glide ratio, the nature
- of the terrain, the nature of the uses to which the airport will be put, and the
- possibilities for future development.
- 15 (3) The cabinet is empowered to temporarily or permanently revoke any certificate of
- approval or license issued by it when it shall determine that <u>a general aviation</u> and
- 17 airport for other navigation facility is not being maintained or used in accordance
- with the provisions of this chapter and the *administrative*[rules and] regulations
- promulgated <u>in accordance with it</u>[pursuant thereto].
- Section 2. KRS 183.861 is amended to read as follows:
- 21 (1) There is hereby created and established within the cabinet, a commission to be
- 22 known as the "Kentucky Airport Zoning Commission" which, notwithstanding the
- provisions of KRS Chapters 100 and 147, shall be empowered to issue orders, rules,
- and regulations pertaining to use of land within and around the facilities identified
- in subsection (2) of this section as will promote the public interest and protect and
- 26 encourage the proper use of the airports and their facilities.
- 27 (2) The commission shall have jurisdiction over land use issues around the following

  12 aircraft, aircraft power plants, and accessories, including the repair, packing, and
  13 maintenance of parachutes; the design, establishment, construction, extension,
  14 operation, improvement, repair, or maintenance of airports or other air navigation
  15 facilities; and instruction in flying or ground subjects pertaining thereto.
- 16 (2) "Aircraft" means any contrivance now known, or hereafter invented, used or 17 designed for navigation of or flight in the air.
- 18 (3) "Air navigation" means the operation or navigation of aircraft in the air space over 19 this state, or upon any airport within this state.
- 20 (4) Air navigation facility means any facility other than one owned or controlled by 21 the United States, used in, available for use in, or designed for use in, aid of air 22 navigation, including airports, rights, interests, or easements in the navigable air 23 space, and any structures, mechanisms, lights, beacons, markers, communicating 24 systems, or other instruments or devices used or useful as an aid, or constituting an 25 advantage or convenience, to the safe taking off, navigation, and landing of aircraft, or the safe and efficient operation or maintenance of an airport, and any 26 27 combination of any or all of such facilities.

15	which obstructs the air space required for the flight of aircraft in landing or taking		
16	off at any airport or is otherwise hazardous to such landing or taking off.		
17	(8) [(9)] "Certificate" means a certificate issued by the cabinet.		
18	(9) [(10)] "Civil aircraft" means any aircraft other than a public aircraft.		
19	(10) [(11)] "Charter operator" means all persons who transport or seek to transport		
20	persons or property in intrastate commerce for hire on unscheduled service and not		
21	between fixed points.		
22	(11) [(12)] "Commercial airport" means an airport certified by the Federal Aviation		
23	Administration in accordance with 14 C.F.R. <u>pt.</u> [Part] 139.		
24	(12)[(13)] "Common carrier" shall include all carriers for hire or compensation by air		
25	who operate, or seek to operate, over fixed routes or between fixed termini within		
26	the Commonwealth of Kentucky.		
27	(13)[(14)] "Commuter air carrier" means a common carrier of persons or property in

25	(17) "Operate," as pertains to an unmanned aircraft, means the actions taken by an				
26	operator of an unmanned aircraft. "Operate" refers only to the actions of an operator				
27	on the ground and is not intended to regulate an unmanned aircraft flying in

- 2 (18) "Operation of aircraft" or "operate aircraft" means the use, navigation, or piloting of
- 3 aircraft in the air space over this state, or upon any airport within this state. Any
- 4 person who causes or authorizes the operation of aircraft, whether with or without
- the right of legal control as owner, lessee, or otherwise of the aircraft, shall be 5
- 6 deemed to be engaged in the operation of aircraft within the meaning of the statutes
- 7 of this state.
- 8 (19) "Operator" means a person operating or flying an unmanned aircraft.
- 9 (20) "Overhead line" means any cable, pipeline, wire, or similar substance of any kind or
- 10 description.
- 11 (21) "Permit" means a permit issued by the cabinet.
- 12 (22) "Public aircraft" means an aircraft used exclusively in the service of any
- 13 government or of any political subdivision thereof, including the government of the
- 14 state, territory, or possession of the United States, or the District of Columbia, but
- 15 not including any government-owned aircraft engaged in carrying persons or
- 16 property for commercial purposes.
- 17 (23) "Public airport" means any airport which is used or to be used for public purposes
- 18 under the control of a public agency, the landing area of which is publicly owned.
- 19 (24) "Public use airport" means any airport in the state airport plan open for use by the
- 20 general public, not including a private airport used primarily for the benefit of the
- 21 owner.
- 22 (25) "State airport plan" means the plan of the cabinet for the development of public and
- 23 certain private airports for the benefit of the people of this state.
- 24 (26) "State airway" means a route in the navigable air space over the lands or waters of
- 25 this state, designated by the cabinet as a route suitable for air navigation.
- 26 (27) "Structure" means any object constructed or installed by man, including but not
- 27 limited to buildings, towers, smokestacks, and overhead transmission lines.

- 1 (28) "Tree" includes objects of natural growth.
- 2 (29) "Unmanned aircraft" means an aircraft operated without the possibility of direct
- 3 human intervention from within or on the aircraft.
- 4 (30) "Unmanned aircraft facility map" means a map that may be developed by a
- 5 commercial airport to display the airport facility's airspace overlaid with latitude
- and longitude rectangular gridlines, or any other commercially available system,
- that reflects the areas where it is unsafe to operate an unmanned aircraft without
- 8 authorization by the commercial airport operator on property owned by a
- 9 commercial airport and in specific areas consistent with obstructions to navigation
- 10 under 14 C.F.R. <u>pt.[Part]</u> 77.
