2	Be it enacted by the General Assembly of the Commonwealth of Kentucky:		
3	→ Section 1. KRS 48.630 is amended to read as follows:		
4	(1) As used in this section, "unbudgeted federal funds" means any federal funds that		
5	have not been appropriated in any enacted branch budget bill.		
6	(2) [An]Unbudgeted <u>federal funds</u> [appropriation] shall not be allotted without prior		
7	review and action by the Interim Joint Committee on Appropriations and Revenue		
8	as provided for in this section.		
9	(3) [(2)] Except as otherwise provided in this section, any request for allotment of		
10	unbudgeted federal funds [appropriations] from any fund source shall be made in		
11	writing by the head of the budget unit and transmitted simultaneously to the state		
12	budget director and the Interim Joint Committee on Appropriations and Revenue.		
13	(4)[(3)] The state budget director may recommend a proposed revision to a specified		
14	federal appropriation in any branch budget bill to the Interim Joint Committee on		
15	Appropriations and Revenue by the seventh day of each month.		
16	(5)[(4)] If the Interim Joint Committee on Appropriations and Revenue fails to review		
17	and act upon the proposed revision by the last day of the month, the proposed		
18	revision shall be deemed to have been reviewed and favorably acted upon.		
19	$(\underline{6})$ The Interim Joint Committee on Appropriations and Revenue shall review the		
20	proposed <u>revision to a specified federal</u> [expenditure of the unbudgeted]		
21	appropriation for conformance with the purposes of the federal funds, [proposed		
22	appropriation and] the enacted branch budget bill, and any other relevant statute[,]		
23	by the last day of each month.		
24	(7)[(6)] If the Interim Joint Committee on Appropriations and Revenue disapproves of		
25	the proposed revision of the enacted <u>federal</u> appropriation, the budget adjustment		
26	shall be invalid unless it is:		
27	(a) Revised to comply with the objections of the committee; or

1	(b) '	The committee is informed, in writing, in detail, within thirty (30) days of the	
2	•	committee's disapproval, that a determination has been made not to comply

4	<u>(8)</u> [(7)]	If an emergency unbudgeted <u>federal</u> appropriation revision is required due to a	
5	declar	red natural disaster, calamity, or impending deficit in an enacted <u>federal</u>	
6	appro	priation as certified by the Governor, the state budget director may effect an	
7	emerg	gency revised <u>federal</u> appropriation, with the approval of the secretary of the	
8	Finance and Administration Cabinet, and with concurrent notification to the Interim		
9	Joint (Committee on Appropriations and Revenue of the action and its justification.	
10	<u>(9)</u> [(8)]	If a budget unit not listed in any enacted branch budget bill receives	
11	unanti	cipated[restricted funds or] federal funds, the secretary of the Finance and

13	appro	priate documentation of the amount, source, purpose, necessity, and use of the

24	unbud	lgeted[restricted funds or] federal funds or revisions to appropriations in	
25	excess	s of any enacted branch budget bill; however, in the event of a revision, an	
26	institu	tion of higher education shall report unbudgeted[restricted funds and] federal

2	(11) [(10)] Unbudgeted federal funds [appropriations] for expenditure in the judicial
3	branch budget and the legislative branch budget shall be exempt from all conditions
4	and procedures in this section, except that each branch head, or its designee, shall
5	report unbudgeted[restricted funds and] federal funds to the Interim Joint
6	Committee on Appropriations and Revenue and transmit an informational copy to
7	the state budget director.
8	(12)[(11)] The Legislative Research Commission shall maintain records of the findings
9	of the Interim Joint Committee on Appropriations and Revenue and the
10	determinations and reports of actions by the state budget director and transmit these
11	records to the General Assembly when next convened.
