1 AN ACT creating the Classification of Workers in the Construction Industry Task

- 3 Be it enacted by the General Assembly of the Commonwealth of Kentucky:
- 4 → Section 1. The Legislative Research Commission shall establish the
- 5 Classification of Workers in the Construction Industry Task Force.
- Section 2. The duties of the task force shall include but are not limited to:
- 7 (1) Studying the cooperation and sharing of information between relevant state
- 8 and federal agencies as it relates to the classification of workers in the construction
- 9 industry;
- 10 (2) Studying the existing methods, both in Kentucky and in other jurisdictions, of
- preventing, investigating, receiving complaints, and taking enforcement action against
- 12 employers that incorrectly classify employees;
- 13 (3) Studying ways to prevent the incorrect classification of workers, such as
- through education of employers, employees, and the general public or changes to statutes
- or regulations; and
- 16 (4) Developing a comprehensive plan with measurable goals to reduce the
- practice of incorrectly classifying employees in the Commonwealth.
- The task force shall be composed of the following members,
- with final membership of the task force being subject to the consideration and approval of
- 20 the Legislative Research Commission:
- 21 (a) Three members of the Senate, two to be appointed by the President of the
- Senate and one to be appointed by the Minority Floor Leader of the Senate;
- 23 (b) Three members of the House of Representatives, two to be appointed by the
- 24 Speaker of the House and one to be appointed by the Minority Floor Leader of the House;
- 25 (c) The commissioner of the Department of Workers' Claims or designee;
- 26 (d) The commissioner of the Department of Workplace Standards or designee;
- 27 (e) The commissioner of the Department of Revenue or designee;

(f) The commissioner of the Department of Workforce Investment or designee;

- 2 (g) The president of the Kentucky Employers' Mutual Insurance or designee;
- 3 (h) The president and chief executive officer of the Kentucky Chamber of
- 4 Commerce or designee;

- 5 (i) Three representatives of the Indiana/Kentucky/Ohio Regional Council of
- 6 Carpenters submitted by the organization;
- 7 (j) Three representatives of the construction industry, one to be chosen by the
- 8 Speaker of the House, one to be chosen by the President of the Senate, and one to be
- 9 chosen jointly by the Speaker of the House and the President of the Senate, from a list of
- six candidates, consisting of two candidates submitted by the Indiana/Kentucky Chapter
- of the Associated Builders and Contractors, two candidates submitted by the Associated
- 12 General Contractors of Kentucky, and two candidates submitted by the Home Builders
- 13 Association of Kentucky; and
- 14 (k) One representative from a public employer to be selected from a list of three
- candidates, consisting of one candidate submitted by the Kentucky League of Cities, one
- 16 candidate submitted by the Kentucky Association of Counties, and one candidate
- submitted by the Kentucky School Boards Association.
- 18 (2) The President of the Senate and the Speaker of the House shall each appoint
- one co-chair of the task force from among that chamber's members appointed to the task

- → Section 4. The task force shall meet at least monthly during the 2020 Interim of
- 22 the General Assembly. The task force shall submit its findings, recommendations, and
- 23 any proposed legislation to the Legislative Research Commission for referral to the
- 24 appropriate committee or committees by December 1, 2020.
- 25 → Section 5. Provisions of this Resolution to the contrary notwithstanding, the
- 26 Legislative Research Commission shall have the authority to alternatively assign the
- 27 issues identified herein to an interim joint committee or subcommittee thereof and to
