There is hereby appropriated to Economic Development 5 supplemental General Fund moneys in the amount of \$641,000 in fiscal year 2017-2018 6 for new debt service to support up to \$15,000,000 in new bonds for the Kentucky 7 Economic Development Finance Authority Loan Pool. At the discretion of the Kentucky 8 Economic Development Partnership, in lieu of Bond Funds, funds in an amount not to 9 exceed \$15,000,000 may be appropriated from the General Fund Surplus Account (KRS 10 48.700) or the Budget Reserve Trust Fund Account (KRS 48.705). These funds shall be 11 used to support programs administered by the Kentucky Economic Development Finance 12 Authority for the sole purpose of facilitating a private sector investment of not less than 13 \$1,000,000,000 in one or more locations in the Commonwealth. This authorization shall 14 expire on June 30, 2018, if the private sector investment has not commenced prior to that 15 date.
