

1 A RESOLUTION adjourning the House of Representatives in honor and loving
2 memory of Lindsay Eugene Hearn Sr.

3 WHEREAS, Lindsay Eugene Hearn was born in Quitman, Mississippi, on July 30,
4 1929, the cherished son of Marianna and Landy Hearn; and

5 WHEREAS, Lindsay Eugene Hearn was a veteran of the United States Army who
6 moved to Louisville in 1956; and

7 WHEREAS, Lindsay Eugene Hearn was a longtime member of Christ Temple
8 Christian Life Center, where he served as a deacon, on the usher board, and in several
9 other capacities. In 2006 he became a member of Word of Faith Church of Deliverance;

11 WHEREAS, Lindsay Eugene Hearn was an employee at Reynolds Metals for 35
12 years before his retirement in 1989; and

13 WHEREAS, Lindsay Eugene Hearn, devoted steward of God and cherished
14 husband, father, and grandfather, departed this earthly life on August 14, 2019, leaving
15 his family, friends, and all those whose lives he touched in solemn mourning; and

16 WHEREAS, Lindsay Eugene Hearn was preceded in death by his parents; wife of
17 47 years, Joann B. Hearn; and children, Lindsay E. Hearn Jr., Latanya Hearn, Anthony
