2 (1) The Secretary of State shall receive a fee of five hundred dollars (\$500) for a 3 candidate for statewide elected state office or the Congress, two hundred dollars 4 (\$200) for a candidate for Commonwealth's attorney, the General Assembly, or the 5 District Court, Circuit Court, Court of Appeals, or Supreme Court, twenty dollars (\$20) for candidates for a city office, fifty dollars (\$50) for other candidates who 6 7 file with the Secretary of State for each notification and declaration and petition 8 filed with him, and fifty dollars (\$50) for a write-in candidate for office, to be paid 9 by the candidate, or the candidate's representative, when the notification and 10 declaration and petition or declaration of intent is filed.

(2) The county clerk shall receive a fee pursuant to KRS 64.012 for each notification and declaration and petition filed with him to be paid by the candidate at the time of the filing.
