11	(1)	The Attorney General shall appoint a deputy attorney general, who shall have the
12		same qualifications required of a Circuit Judge except for residence in a district and
13		who shall receive the same salary as a Circuit Judge, to serve at the pleasure of the
14		Attorney General and to perform the duties he may designate. The Attorney General
15		may appoint two (2) assistant deputy attorneys general, who shall have the same
16		qualifications required of a District Judge except for residence in a district and who
17		shall receive the same salary as a District Judge, to serve at the pleasure of the
18		Attorney General and to perform the duties he may designate. In addition thereto, he
19		shall[may] appoint a solicitor[another assistant deputy attorney] general to serve at
20		the pleasure of the Attorney General and to perform the duties he may
21		designate [function as administrator] and shall set his salary.
22	(2)	In addition to the deputy attorney general, the Attorney General shall appoint such
23		assistants and special attorneys as he deems necessary to transact the business of the
24		Department of Law, and to perform the duties he may designate. The deputy
25		attorney general, assistant deputy attorneys general, assistants, and special attorneys

27 to perform such duties as may be performed by the Attorney General. The Attorney

shall have full power, as authorized and under the direction of the Attorney General,

1 General shall be responsible for the official acts of his deputy, assistant deputy 2 attorneys general, assistants, and special attorneys. 3 (3) In addition to the appointment and designation of a deputy, assistant deputy 4 attorneys general, assistants, and special attorneys pursuant to subsections (1) and 5 (2) of this section, the Attorney General may enter into such contracts for legal 6 services as he deems necessary and advisable. Such contracts shall be subject to the 7 relevant provisions of the Kentucky Model Procurement Code in KRS Chapter 45A. 8 (4) Each assistant or special attorney so appointed or designated shall be a person 9 admitted to the practice of law by the Supreme Court of this Commonwealth and 10 shall qualify by taking the oath of office.
