

1 AN ACT relating to abortion and declaring an emergency.

2 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

3 ➔SECTION 1. A NEW SECTION OF KRS 311.710 TO 311.830 IS CREATED
4 TO READ AS FOLLOWS:

5 *As used in Sections 1 to 7 of this Act:*

6 *(1) "Abortion" has the same meaning as in KRS 311.720. However, as used in*
7 *Sections 1 to 7 of this Act, an abortion shall not include the use of any means to*
8 *terminate the pregnancy of a woman if done with an intent to:*

9 *(a) Save the life or preserve the health of the unborn child;*

10 *(b) Remove a dead unborn child caused by spontaneous abortion; or*

11 *(c) Remove an ectopic pregnancy;*

12 *(2) "Born alive" or "live birth" means the complete expulsion or extraction of an*
13 *infant from his or her mother, regardless of the state of gestational development,*
14 *who, after expulsion or extraction, whether or not the umbilical cord has been*
15 *cut or the placenta is attached, and regardless of whether the expulsion or*
16 *extraction occurs as a result of natural or induced labor, cesarean section, or*
17 *induced abortion, shows any evidence of life including but not limited to one (1)*
18 *or more of the following:*

19 *(a) Breathing;*

20 *(b) A heartbeat;*

21 *(c) Umbilical cord pulsation; or*

22 *(d) Definite movement of voluntary muscles;*

23 *(3) "Consent" means the voluntary agreement or acquiescence by a person of age*
24 *and with the requisite mental capacity who is not under duress or coercion and*
25 *who has knowledge or understanding of the act or action to which he or she has*
26 *agreed or acquiesced;*

27 *(4) "Healthcare provider" means any individual who may be asked to participate in*

1 any way in a healthcare service, including but not limited to a physician;
2 physician's assistant; nurse; nurse's aide; medical assistant; hospital employee;
3 clinic employee; nursing home employee; pharmacist; pharmacy employee;
4 researcher; medical or nursing school faculty or employee; or any professional,
5 paraprofessional, or any other person who furnishes or assists in the furnishing
6 of healthcare services;

7 (5) "Infant" means a child of the species homo sapiens who has been completely
8 expulsed or extracted from his or her mother, regardless of the stage of
9 gestational development, until the age of thirty (30) days post birth;

10 (6) "Medical facility" means any public or private hospital, clinic, center, medical
11 school, medical training institution, healthcare facility, physician's office,
12 infirmary, dispensary, ambulatory surgical treatment center, or other institution
13 or location wherein medical care is provided to any person;

14 (7) "Nurse" has the same meaning as in KRS 314.011;

15 (8) "Physician" has the same meaning as in KRS 311.720; and

16 (9) "Unborn child" has the same meaning as in KRS 311.781.

17 ➔SECTION 2. A NEW SECTION OF KRS 311.710 TO 311.830 IS CREATED
18 TO READ AS FOLLOWS:

19 (1) The General Assembly of the Commonwealth of Kentucky hereby finds that:

20 (a) The Commonwealth of Kentucky has a paramount interest in protecting all
21 human life;

22 (b) If an attempted abortion results in the live birth of an infant, the infant is a
23 legal person for all purposes under the laws of this Commonwealth;

24 (c) It is not an infringement on a woman's right to terminate her pregnancy for
25 this Commonwealth to assert its interest in protecting an infant whose live
26 birth occurred as the result of an attempted abortion; and

27 (d) Without proper legal protection, newly born infants who survive attempted

1 abortions will be denied appropriate life-saving or life-sustaining medical
 2 care and treatment and will be left to die.

3 (2) Based on the findings in subsection (1) of this section, the purposes of Sections 1
 4 to 7 of this Act are to:

5 (a) Ensure the protection and promotion of the health and well-being of all
 6 infants born alive in this Commonwealth; and

7 (b) Mandate that healthcare providers give medically appropriate and
 8 reasonable life-saving and life-sustaining medical care and treatment to all
 9 born alive infants.

10 ➔SECTION 3. A NEW SECTION OF KRS 311.710 TO 311.830 IS CREATED
 11 TO READ AS FOLLOWS:

12 (1) A person shall not deny or deprive an infant of:

13 (a) Nourishment with the intent to cause or allow the death of the infant for
 14 any reason including but not limited to:

15 1. The infant was born with a handicap;

16 2. The infant is not wanted by the parent or guardian; or

17 3. The infant is born alive by natural or artificial means; or

18 (b) Medically appropriate and reasonable medical care, medical treatment, or
 19 surgical care.

20 (2) (a) A physician performing an abortion shall take all medically appropriate
 21 and reasonable steps to preserve the life and health of a born alive infant. If
 22 an abortion performed in a:

23 1. Hospital results in a live birth, the physician attending the abortion
 24 shall provide immediate medical care to the infant, inform the mother
 25 of the live birth, and request transfer of the infant to an on-duty
 26 resident or emergency care physician who shall provide medically
 27 appropriate and reasonable medical care and treatment to the infant;

or

2. Medical facility other than a hospital results in a live birth, the physician attending the abortion shall provide immediate medical care to the infant and call 911 for an emergency transfer of the infant to a hospital that shall provide medically appropriate and reasonable medical care and treatment to the infant.

(b) If the physician is unable to perform the duties in paragraph (a) of this subsection because he or she is assisting the woman on whom the abortion was performed, then an attending nurse or other healthcare provider shall assume the duties outlined in paragraph (a) of this subsection.

(3) Any born alive infant, including one (1) born in the course of an abortion procedure, shall be treated as a legal person under the laws of this Commonwealth, with the same rights to medically appropriate and reasonable care and treatment, and a birth certificate shall be issued. In addition, if death occurs after birth, a death certificate shall be issued.

(4) If, before the abortion, the mother, and if married, her husband, has or have stated in writing that she does, or they do, not wish to keep the infant in the event that the abortion results in a live birth, and this writing is not retracted before the attempted abortion, the infant, if born alive, shall immediately upon birth become a ward of the Cabinet for Health and Family Services.

(5) No person shall use any born alive infant for any type of scientific research or other kind of experimentation except as necessary to protect or preserve the life and health of the born alive infant.

(6) (a) The requirements of this section shall not be construed to prevent an infant's parent or guardian from refusing to give consent to medical care, medical treatment, or surgical care which is not medically necessary, appropriate, or reasonable including care or treatment that:

1 1. Is not necessary to save the life of the infant;

2 2. Has a potential risk to the infant's life or health that outweighs the
 3 potential benefit to the infant of the treatment or care; or

4 3. Is treatment that will do no more than temporarily prolong the act of
 5 dying when death is imminent.

6 (b) The parent or guardian of a born alive infant shall not be held criminally or
 7 civily liable for the actions of a physician, nurse, or other healthcare
 8 provider that are in violation of this section and to which the parent or
 9 guardian did not give consent.

10 ➔SECTION 4. A NEW SECTION OF KRS 311.710 TO 311.830 IS CREATED
 11 TO READ AS FOLLOWS:

12 In addition to whatever remedies are available under the laws of this Commonwealth,
 13 failure to comply with the requirements of Section 3 of this Act shall:

14 (1) Provide a basis for a civil action for compensatory and punitive damages. Any
 15 conviction under Section 3 of this Act shall be admissible in a civil suit as prima
 16 facie evidence of a failure to provide medically appropriate and reasonable care
 17 and treatment to a born alive infant. Any civil action may be based on a claim
 18 that the death of or injury to the born alive infant was a result of simple
 19 negligence, gross negligence, wantonness, willfulness, intentional conduct, or
 20 another violation of the legal standard of care;

21 (2) Provide a basis for professional disciplinary action for the suspension or
 22 revocation of the license of a physician, physician's assistant, nurse, or
 23 pharmacist. A conviction of any physician, physician's assistant, nurse, or
 24 pharmacist for failure to comply with subsection (2) of Section 3 of this Act shall
 25 result in the automatic suspension of his or her license for a period of at least one
 26 (1) year and the license shall be reinstated after that time only under such
 27 conditions as the licensing body shall require to ensure compliance with Section

1 3 of this Act; and

2 (3) Provide a basis for recovery for the parent of the infant, or the parent or
 3 guardian of the mother if the mother is a minor, for the wrongful death of the
 4 infant, whether or not the infant was viable at the time the attempted abortion
 5 was performed.

6 ➔SECTION 5. A NEW SECTION OF KRS 311.710 TO 311.830 IS CREATED
 7 TO READ AS FOLLOWS:

8 (1) Nothing in Sections 1 to 7 of this Act shall be construed to affirm, deny, expand,
 9 or contract any legal status or legal right applicable to any member of the species
 10 homo sapiens at any point prior to being born alive.

11 (2) Nothing in Sections 1 to 7 of this Act shall be construed to affect existing federal
 12 or state law regarding abortion.

13 (3) Nothing in Sections 1 to 7 of this Act shall be construed as creating or
 14 recognizing a right to abortion.

15 (4) Nothing in Sections 1 to 7 of this Act shall be construed to alter generally
 16 accepted medical standards.

17 ➔SECTION 6. A NEW SECTION OF KRS 311.710 TO 311.830 IS CREATED
 18 TO READ AS FOLLOWS:

19 Any provision of Sections 1 to 7 of this Act held to be invalid or unenforceable by its
 20 terms, or as applied to any person or circumstance, shall be construed so as to give it
 21 the maximum effect permitted by law, unless such holding shall be one of utter
 22 invalidity or unenforceability, in which event the provision shall be deemed severable
 23 herefrom and shall not affect the remainder hereof or the application of such provision
 24 to other persons not similarly situated or to other dissimilar circumstances.

25 ➔SECTION 7. A NEW SECTION OF KRS 311.710 TO 311.830 IS CREATED
 26 TO READ AS FOLLOWS:

27 (1) The General Assembly, by joint resolution, may appoint one (1) or more of its

1 members, who sponsored or cosponsored this Act in his or her official capacity,
2 to intervene as a matter of right in any case in which the constitutionality of this
3 law is challenged.

4 (2) Nothing in this section shall be construed as a waiver or diminishment of any
5 constitutional, common law, or statutory defenses, privileges, or immunities that
6 may apply to any legislator, legislative staff, legislative agency or entity, or the
7 legislative branch.

8 ➔Section 8. KRS 311.595 is amended to read as follows:

9 If the power has not been transferred by statute to some other board, commission, or
10 agency of this state, the board may deny an application or reregistration for a license;
11 place a licensee on probation for a period not to exceed five (5) years; suspend a license
12 for a period not to exceed five (5) years; limit or restrict a license for an indefinite period;
13 or revoke any license heretofore or hereafter issued by the board, upon proof that the
14 licensee has:

15 (1) Knowingly made or presented, or caused to be made or presented, any false,
16 fraudulent, or forged statement, writing, certificate, diploma, or other thing, in
17 connection with an application for a license or permit;

18 (2) Practiced, or aided or abetted in the practice of fraud, forgery, deception, collusion,
19 or conspiracy in connection with an examination for a license;

20 (3) Committed, procured, or aided in the procurement of an unlawful abortion,
21 including a partial-birth abortion;

22 (4) Entered a guilty or nolo contendere plea, or been convicted, by any court within or
23 without the Commonwealth of Kentucky of a crime as defined in KRS 335B.010, if
24 in accordance with KRS Chapter 335B;

25 (5) Been convicted of a misdemeanor offense under KRS Chapter 510 involving a
26 patient, or a felony offense under KRS Chapter 510, 530.064(1)(a), or 531.310, or
27 been found by the board to have had sexual contact as defined in KRS 510.010(7)

- 1 with a patient while the patient was under the care of the physician;
- 2 (6) Become addicted to a controlled substance;
- 3 (7) Become a chronic or persistent alcoholic;
- 4 (8) Been unable or is unable to practice medicine according to acceptable and
5 prevailing standards of care by reason of mental or physical illness or other
6 condition including but not limited to physical deterioration that adversely affects
7 cognitive, motor, or perceptive skills, or by reason of an extended absence from the
8 active practice of medicine;
- 9 (9) Engaged in dishonorable, unethical, or unprofessional conduct of a character likely
10 to deceive, defraud, or harm the public or any member thereof;
- 11 (10) Knowingly made, or caused to be made, or aided or abetted in the making of, a false
12 statement in any document executed in connection with the practice of his
13 profession;
- 14 (11) Employed, as a practitioner of medicine or osteopathy in the practice of his
15 profession in this state, any person not duly licensed or otherwise aided, assisted, or
16 abetted the unlawful practice of medicine or osteopathy or any other healing art;
- 17 (12) Violated or attempted to violate, directly or indirectly, or assisted in or abetted the
18 violation of, or conspired to violate any provision or term of any medical practice
19 act, including but not limited to the code of conduct promulgated by the board under
20 KRS 311.601 or any other valid regulation of the board;
- 21 (13) Violated any agreed order, letter of agreement, final order, or emergency order
22 issued by the board;
- 23 (14) Engaged in or attempted to engage in the practice of medicine or osteopathy under a
24 false or assumed name, or impersonated another practitioner of a like, similar, or
25 different name;
- 26 (15) Obtained a fee or other thing of value on the fraudulent representation that a
27 manifestly incurable condition could be cured;

- 1 (16) Willfully violated a confidential communication;
- 2 (17) Had his license to practice medicine or osteopathy in any other state, territory, or
3 foreign nation revoked, suspended, restricted, or limited or has been subjected to
4 other disciplinary action by the licensing authority thereof. This subsection shall not
5 require relitigation of the disciplinary action;
- 6 (18) Failed or refused, without legal justification, to practice medicine in a rural area of
7 this state in violation of a valid medical scholarship loan contract with the trustees
8 of the rural Kentucky medical scholarship fund;
- 9 (19) Given or received, directly or indirectly, from any person, firm, or corporation, any
10 fee, commission, rebate, or other form of compensation for sending, referring, or
11 otherwise inducing a person to communicate with a person licensed under KRS
12 311.530 to 311.620 in his professional capacity or for any professional services not
13 actually and personally rendered; provided, however, that nothing contained in this
14 subsection shall prohibit persons holding valid and current licenses under KRS
15 311.530 to 311.620 from practicing medicine in partnership or association or in a
16 professional service corporation authorized by KRS Chapter 274, as now or
17 hereinafter amended, or from pooling, sharing, dividing, or apportioning the fees
18 and moneys received by them or by the partnership, corporation, or association in
19 accordance with the partnership agreement or the policies of the board of directors
20 of the corporation or association. Nothing contained in this subsection shall
21 abrogate the right of two (2) or more persons holding valid and current licenses
22 under KRS 311.530 to 311.620 to receive adequate compensation for concurrently
23 rendering professional care to a single patient and divide a fee, if the patient has full
24 knowledge of this division and if the division is made in proportion to the services
25 performed and responsibility assumed by each;
- 26 (20) Been removed, suspended, expelled, or disciplined by any professional medical
27 association or society when the action was based upon what the association or

1 society found to be unprofessional conduct, professional incompetence, malpractice,
 2 or a violation of any provision of KRS Chapter 311. This subsection shall not
 3 require relitigation of the disciplinary action;

4 (21) Been disciplined by a licensed hospital or medical staff of the hospital, including
 5 removal, suspension, limitation of hospital privileges, failing to renew privileges for
 6 cause, resignation of privileges under pressure or investigation, or other disciplinary
 7 action if the action was based upon what the hospital or medical staff found to be
 8 unprofessional conduct, professional incompetence, malpractice, or a violation of
 9 any provisions of KRS Chapter 311. This subsection shall not require relitigation of
 10 the disciplinary action;~~{or}~~

11 (22) Failed to comply with the requirements of KRS 213.101, 311.782, or 311.783 or
 12 failed to submit to the Vital Statistics Branch in accordance with a court order a
 13 complete report as described in KRS 213.101; or

14 **(23) As provided in subsection (2) of Section 4 of this Act, been convicted of a**
 15 **violation of subsection (2) of Section 3 of this Act.**

16 ➔Section 9. KRS 311.850 is amended to read as follows:

17 (1) The board may revoke, suspend, deny, decline to renew, limit, or restrict the license
 18 of a physician assistant, or may fine, reprimand or place a physician assistant on
 19 probation for no more than five (5) years upon proof that a physician assistant has:

20 (a) Knowingly made or presented or caused to be made or presented any false,
 21 fraudulent, or forged statement, writing, certificate, diploma, or other
 22 document relating to an application for licensure;

23 (b) Practiced, aided, or abetted in the practice of fraud, forgery, deception,
 24 collusion, or conspiracy relating to an examination for licensure;

25 (c) Been convicted of a crime as defined in KRS 335B.010, if in accordance with
 26 KRS Chapter 335B;

27 (d) Become addicted to or is an abuser of alcohol, drugs, or any illegal substance;

- 1 (e) Developed a physical or mental disability or other condition that presents a
2 danger in continuing to practice medicine to patients, the public, or other
3 health care personnel;
- 4 (f) Knowingly made or caused to be made or aided or abetted in the making of a
5 false statement in any document executed in connection with the practice of
6 medicine or osteopathy;
- 7 (g) Performed any act or service as a physician assistant without a designated
8 supervising physician;
- 9 (h) Exceeded the scope of medical services described by the supervising
10 physician in the applications required under KRS 311.854;
- 11 (i) Exceeded the scope of practice for which the physician assistant was
12 credentialed by the governing board of a hospital or licensed health care
13 facility under KRS 311.856 and 311.858;
- 14 (j) Aided, assisted, or abetted the unlawful practice of medicine or osteopathy or
15 any healing art, including the unlawful practice of physician assistants;
- 16 (k) Willfully violated a confidential communication;
- 17 (l) Performed the services of a physician assistant in an unprofessional,
18 incompetent, or grossly or chronically negligent manner;
- 19 (m) Been removed, suspended, expelled, or placed on probation by any health care
20 facility or professional society for unprofessional conduct, incompetence,
21 negligence, or violation of any provision of this section or KRS 311.858 or
22 311.862;
- 23 (n) Violated any applicable provision of administrative regulations relating to
24 physician assistant practice;
- 25 (o) Violated any term of probation or other discipline imposed by the board;~~[-or]~~
- 26 (p) Failed to complete the required number of hours of approved continuing
27 education; **or**

1 *(g) As provided in subsection (2) of Section 4 of this Act, been convicted of a*
2 *violation of subsection (2) of Section 3 of this Act.*

3 (2) All disciplinary proceedings against a physician assistant shall be conducted in
4 accordance with the provisions of KRS 311.591, 311.592, 311.593, 311.599, and
5 KRS Chapter 13B and related administrative regulations promulgated under KRS
6 Chapter 311.

7 ➔Section 10. KRS 311.990 (Effective until July 1, 2019) is amended to read as
8 follows:

9 (1) Any person who violates KRS 311.250 shall be guilty of a violation.

10 (2) Any college or professor thereof violating the provisions of KRS 311.300 to
11 311.350 shall be civilly liable on his bond for a sum not less than one hundred
12 dollars (\$100) nor more than one thousand dollars (\$1,000) for each violation,
13 which may be recovered by an action in the name of the Commonwealth.

14 (3) Any person who presents to the county clerk for the purpose of registration any
15 license which has been fraudulently obtained, or obtains any license under KRS
16 311.380 to 311.510 by false or fraudulent statement or representation, or practices
17 podiatry under a false or assumed name or falsely impersonates another practitioner
18 or former practitioner of a like or different name, or aids and abets any person in the
19 practice of podiatry within the state without conforming to the requirements of KRS
20 311.380 to 311.510, or otherwise violates or neglects to comply with any of the
21 provisions of KRS 311.380 to 311.510, shall be guilty of a Class A misdemeanor.
22 Each case of practicing podiatry in violation of the provisions of KRS 311.380 to
23 311.510 shall be considered a separate offense.

24 (4) Each violation of KRS 311.560 shall constitute a Class D felony.

25 (5) Each violation of KRS 311.590 shall constitute a Class D felony. Conviction under
26 this subsection of a holder of a license or permit shall result automatically in
27 permanent revocation of such license or permit.

- 1 (6) Conviction of willfully resisting, preventing, impeding, obstructing, threatening, or
2 interfering with the board or any of its members, or of any officer, agent, inspector,
3 or investigator of the board or the Cabinet for Health and Family Services, in the
4 administration of any of the provisions of KRS 311.550 to 311.620 shall be a Class
5 A misdemeanor.
- 6 (7) Each violation of subsection (1) of KRS 311.375 shall, for the first offense, be a
7 Class B misdemeanor, and, for each subsequent offense shall be a Class A
8 misdemeanor.
- 9 (8) Each violation of subsection (2) of KRS 311.375 shall, for the first offense, be a
10 violation, and, for each subsequent offense, be a Class B misdemeanor.
- 11 (9) Each day of violation of either subsection of KRS 311.375 shall constitute a
12 separate offense.
- 13 (10) (a) Any person who intentionally or knowingly performs an abortion contrary to
14 the requirements of KRS 311.723(1) shall be guilty of a Class D felony; and
15 (b) Any person who intentionally, knowingly, or recklessly violates the
16 requirements of KRS 311.723(2) shall be guilty of a Class A misdemeanor.
- 17 (11) (a) 1. Any physician who performs a partial-birth abortion in violation of KRS
18 311.765 shall be guilty of a Class D felony. However, a physician shall
19 not be guilty of the criminal offense if the partial-birth abortion was
20 necessary to save the life of the mother whose life was endangered by a
21 physical disorder, illness, or injury.
- 22 2. A physician may seek a hearing before the State Board of Medical
23 Licensure on whether the physician's conduct was necessary to save the
24 life of the mother whose life was endangered by a physical disorder,
25 illness, or injury. The board's findings, decided by majority vote of a
26 quorum, shall be admissible at the trial of the physician. The board shall
27 promulgate administrative regulations to carry out the provisions of this

1 subparagraph.

2 3. Upon a motion of the physician, the court shall delay the beginning of
3 the trial for not more than thirty (30) days to permit the hearing, referred
4 to in subparagraph 2. of this paragraph, to occur.

5 (b) Any person other than a physician who performs a partial-birth abortion shall
6 not be prosecuted under this subsection but shall be prosecuted under
7 provisions of law which prohibit any person other than a physician from
8 performing any abortion.

9 (c) No penalty shall be assessed against the woman upon whom the partial-birth
10 abortion is performed or attempted to be performed.

11 (12) Any person who intentionally performs an abortion with knowledge that, or with
12 reckless disregard as to whether, the person upon whom the abortion is to be
13 performed is an unemancipated minor, and who intentionally or knowingly fails to
14 conform to any requirement of KRS 311.732 is guilty of a Class A misdemeanor.

15 (13) Any person who negligently releases information or documents which are
16 confidential under KRS 311.732 is guilty of a Class B misdemeanor.

17 (14) Any person who performs an abortion upon a married woman either with
18 knowledge or in reckless disregard of whether KRS 311.735 applies to her and who
19 intentionally, knowingly, or recklessly fails to conform to the requirements of KRS
20 311.735 shall be guilty of a Class D felony.

21 (15) Any person convicted of violating KRS 311.750 shall be guilty of a Class B felony.

22 (16) Any person who violates KRS 311.760(2) shall be guilty of a Class D felony.

23 (17) Any person who violates KRS 311.770 shall be guilty of a Class D felony.

24 (18) Except as provided in KRS 311.787(3), any person who intentionally violates KRS
25 311.787 shall be guilty of a Class D felony.

26 (19) A person convicted of violating KRS 311.780 shall be guilty of a Class C felony.

27 (20) Except as provided in KRS 311.782(6), any person who intentionally violates KRS

1 311.782 shall be guilty of a Class D felony.

2 (21) Any person who violates KRS 311.783(1) shall be guilty of a Class B misdemeanor.

3 (22) *Any physician, nurse, or other healthcare provider who intentionally violates*
4 *subsection (2) of Section 3 of this Act shall be guilty of a Class D felony;*

5 *(23) Any person who intentionally violates subsection (5) of Section 3 of this Act shall*
6 *be guilty of a Class D felony;*

7 *(24)* Any person who violates KRS 311.810 shall be guilty of a Class A misdemeanor.

8 ~~*(25)*~~~~*(23)*~~ Any professional medical association or society, licensed physician, or
9 hospital or hospital medical staff who shall have violated the provisions of KRS
10 311.606 shall be guilty of a Class B misdemeanor.

11 ~~*(26)*~~~~*(24)*~~ Any administrator, officer, or employee of a publicly owned hospital or
12 publicly owned health care facility who performs or permits the performance of
13 abortions in violation of KRS 311.800(1) shall be guilty of a Class A misdemeanor.

14 ~~*(27)*~~~~*(25)*~~ Any person who violates KRS 311.905(3) shall be guilty of a violation.
