26	(2)	Each	local board of education shall adopt a policy for implementing school-based

decision making in the district which shall include, but not be limited to, a

description of how the district's policies, including those developed pursuant to KRS 160.340, have been amended to allow the professional staff members of a school to be involved in the decision making process as they work to meet educational goals established in KRS 158.645 and 158.6451. The policy may include a requirement that each school council make an annual report at a public meeting of the board describing *the activities of the council during the school year* and the school's progress in meeting the educational goals set forth in KRS 158.6451, and district goals established by the board. The policy shall also address and comply with the following:

- (a) Except as provided in paragraph (b)2. of this subsection <u>and subsection (7) of this section</u>, each participating school shall form a school council composed of two (2) parents, <u>two (2)</u>[three (3)] teachers, and the principal[—or administrator]. The membership of the council may be increased, but it may only be increased proportionately <u>unless an alternative model for implementing school-based decision making has been approved as provided in subsection (7) of this section. A parent representative on the council shall not be an employee or a relative of an employee of the school in which that parent serves, nor shall the parent representative be an employee or a relative of an employee in the district administrative offices. A parent representative shall not be a local board member or a board member's spouse. None of the members shall have a conflict of interest pursuant to KRS Chapter 45A, except the salary paid to district employees;</u>
- (b) 1. The teacher representatives shall be elected for one (1) year terms by a majority of the teachers. [A teacher elected to a school council shall not be involuntarily transferred during his or her term of office.] The parent representatives shall be elected for one (1) year terms. The parent members shall be elected by the parents of students preregistered to

2. The principal shall be the primary administrator and the instructional leader of the school, and with the assistance of the total school staff shall administer the policies established by the school council and the local board.

<u>3.[2.]</u> If a school council establishes committees, it shall adopt a policy to facilitate the participation of interested persons, including, but not limited to, classified employees and parents. The policy shall include the number of committees, their jurisdiction, composition, and the process for membership selection;

- (d) The school council and each of its committees shall determine the frequency of and agenda for their meetings. Matters relating to formation of school councils that are not provided for by this section shall be addressed by local board policy;
- (e) The meetings of the school council shall be open to the public and all interested persons may attend, *including but not limited to members of the local board of education who may attend and participate in council meetings to the same extent as any other interested person*. However, the exceptions to open meetings provided in KRS 61.810 shall apply;
- (f) After receiving notification of the funds available for the school from the local board, the school council shall determine, within the parameters of the total available funds, the number of persons to be employed in each job classification at the school. The council may make personnel decisions on vacancies occurring after the school council is formed but shall not have the authority to recommend transfers or dismissals;
- (g) The school council shall determine which textbooks, instructional materials, and student support services shall be provided in the school. Subject to

> available resources, the local board shall allocate an appropriation to each school that is adequate to meet the school's needs related to instructional materials and school-based student support services, as determined by the school council. The school council shall consult with the school media librarian on the maintenance of the school library media center, including the purchase of instructional materials, information technology, and equipment;

(h) Personnel decisions at the school level shall be as follows:

1. From a list of qualified applicants submitted by the local superintendent, the principal at the participating school shall select personnel to fill vacancies, after consultation with the school council, consistent with paragraph (i)11. of this subsection. The superintendent shall provide additional applicants to the principal upon request when qualified applicants are available. The superintendent may forward to the *principal*[school council] the names of qualified applicants who have pending certification from the Education Professional Standards Board based on recent completion of preparation requirements, out-ofstate preparation, or alternative routes to certification pursuant to KRS 161.028 and 161.048. Requests for transfer shall conform to any employer-employee bargained contract which is in effect;

2. <del>[a. i. ]</del>If the vacancy to be filled is the position of principal, the foutgoing principal shall not serve on the council during the principal selection process. The superintendent shall conduct for the superintendent's designee shall serve as the chair of the council for the purpose of] the hiring process and, after consultation with the school council, shall select someone to fill the principal vacancy; [have voting rights during the selection process.

requirement to implement school-based decision making, and the state board shall grant the exemption. The voting by the parents on the matter of exemption from implementing school-based decision making shall be in an election conducted by the parent and teacher organization of the school or, if none exists, the largest organization of parents formed for this purpose. Notwithstanding the provisions of this section, a local school district shall not be required to implement school-based decision making if the local school district contains only one (1) school.

The Department of Education shall provide professional development activities to assist schools in implementing school-based decision making. First time school council members <del>[elected for the first time ]shall complete a minimum of six (6)</del> clock hours of training in the process of school-based decision making, no later than thirty (30) days after the beginning of the service year for which they are elected to serve. School council members who have served on a school council at least one (1) year shall complete a minimum of three (3) clock hours of training in the process of school-based decision making no later than one hundred twenty (120) days after the beginning of the service year for which they are elected to serve. Experienced members may participate in the training for new members to fulfill their training requirement. School council training required under this subsection shall be conducted by trainers endorsed by the Department of Education. By November 1 of each year, the principal through the local superintendent shall forward to the Department of Education the names and addresses of each council member and verify that the required training has been completed. School council members elected to fill a vacancy shall complete the applicable training within thirty (30) days of their election.

(7) A school that chooses to have school-based decision making but would like to be exempt from the administrative structure set forth by this section may develop <u>an</u> alternative[a] model for implementing school-based decision making, including but

not limited to a description of the membership, organization, duties, and responsibilities of a school council. The school shall submit the model through the local board of education to the commissioner of education and the Kentucky Board of Education, which shall have final authority for approval. The application for approval of the model shall show evidence that it has been developed by representatives of the parents, students, certified personnel, and the administrators of the school and that two-thirds (2/3) of the faculty have agreed to the model.

- The Kentucky Board of Education, upon recommendation of the commissioner of education, shall adopt by administrative regulation a formula by which school district funds shall be allocated to each school council. Included in the school council formula shall be an allocation for professional development that is at least sixty-five percent (65%) of the district's per pupil state allocation for professional development for each student in average daily attendance in the school. The school council shall plan professional development in compliance with requirements specified in KRS 156.095, except as provided in KRS 158.649. School councils of small schools shall be encouraged to work with other school councils to maximize professional development opportunities.
- (9) (a) No board member, superintendent of schools, district employee, or member of a school council shall intentionally engage in a pattern of practice which is detrimental to the successful implementation of or circumvents the intent of school-based decision making to allow the professional staff members of a school and parents to be involved in the decision making process in working toward meeting the educational goals established in KRS 158.645½[ and] 158.645½, and district goals established by the board, or to make decisions in areas of policy assigned to a school council pursuant to paragraph (i) of subsection (2) of this section.
- (b) An affected party who believes a violation of this subsection has occurred may

1		file a written complaint with the Office of Education Accountability. The
2		office <u>may</u> [shall] investigate the complaint and[ <u>resolve the conflict</u> ], if
3		appropriate, refer[possible, or forward] the matter to the Kentucky Board of
4		Education for further review.
5		(c) The Kentucky Board of Education shall conduct a hearing in accordance with
6		KRS Chapter 13B for complaints referred by the Office of Education
7		Accountability.
8		(d) If the state board determines a violation has occurred, the party shall be
9		subject to reprimand. A second violation of this subsection may be grounds
10		for removing a superintendent, a member of a school council, or school board
11		member from office or grounds for dismissal of an employee for misconduct
12		in office or willful neglect of duty.
13		[(e) Notwithstanding paragraph (d) of this subsection and KRS 7.410(2)(c), if the
14		state board determines a violation of the confidentiality requirements set forth
15		in subsection (2)(h)2. of this section by a school council member has
16		occurred, the state board shall remove the member from the school council,
17		and the member shall be permanently prohibited from serving on any school

19	(10)	Notwithstanding subsections (1) to (9) of this section, a school's right to establish or

25	(11)	Each school council of a school containing grades K-5 or any combination thereof,
26		or if there is no school council, the principal, shall develop and implement a
27		wellness policy that includes moderate to vigorous physical activity each day and

encourages healthy choices among students. The policy may permit physical activity
to be considered part of the instructional day, not to exceed thirty (30) minutes per
day, or one hundred and fifty (150) minutes per week. Each school council, or if
there is no school council, the principal, shall adopt an assessment tool to determine
each child's level of physical activity on an annual basis. The council or principal
may utilize an existing assessment program. The Kentucky Department of
Education shall make available a list of available resources to carry out the
provisions of this subsection. The department shall report to the Legislative
Research Commission no later than November 1 of each year on how the schools
are providing physical activity under this subsection and on the types of physical
activity being provided. The policy developed by the school council or principal
shall comply with provisions required by federal law, state law, or local board
policy.
Discretionary authority exercised under subsection (2)(h)2.b. of this section shall
not violate provisions of any employer employee bargained contract existing
