- (d) Distillers may sell private selection packages to wine and distilled spirits wholesalers, malt beverage distributors, and microbreweries that hold a quota retail drink or quota retail package license that participated in a private selection event if the private selection packages resulting from the event are sold only through a licensed retailer.
- 12 (5) Hours of sale for souvenir packages sold at retail and private selection packages 13 sold at retail shall be in conformity with KRS 244.290(3).
- 14 (6) Except as provided in this section, souvenir package and private selection package 15 sales to distillery visitors shall be governed by all the statutes and administrative 16 regulations governing the retail sale of distilled spirits by the package.
- 17 (7) Souvenir packages sold to distillery visitors under subsection (3)(b) of this section,

22	premises are located in wet territory or in a precinct that has authorized alcoholic

- 7 Each wholesaler <u>or self-distributing distiller</u> shall pay to the Department of Revenue five
- 8 cents (\$0.05) per case on each case of distilled spirits sold by the wholesaler or self-
- 9 <u>distributing distiller[him]</u> in the state. This tax shall be computed each month according
- to the report required to be filed by KRS 243.850 and shall be paid on or before the date
