A CONCURRENT RESOLUTION urging the Food and Drug Administration of the

2	federal government to implement marketing restrictions and other protective measures to
3	protect children and young adults from the dangers of vaping.
4	WHEREAS, Juul electronic cigarettes have quickly skyrocketed in popularity
5	among teens and college students across the United States; and
6	WHEREAS, educators and students report an alarming level of Juul use in middle
7	and high schools making this an urgent public health problem; and
8	WHEREAS, Juul e-cigarettes are sleek, high tech and easy to hide, look just like
9	USB flash drives and can be charged in the USB port of a computer, and are small
10	enough to fit in a closed hand, and
11	WHEREAS, Juul and other e-cigarettes come in sweet flavors that appeal to youth,
12	and research has shown that flavors play a key role in youth use of tobacco products,
13	including e-cigarettes; and
14	WHEREAS, Juul appears to deliver nicotine more quickly, more effectively and at
15	higher doses than other e-cigarettes, increasing users' risk of addiction; and
16	WHEREAS, research has found that many Juul users don't know the product always
17	contains nicotine, and many teens call use of the product "juuling," indicating they may
18	not realize it is an e-cigarette or tobacco product; and
19	WHEREAS, Juul sales have grown dramatically and now make up more than half
20	the e-cigarette market; and
21	WHEREAS, Juul is putting kids at risk of nicotine addiction and threatens to
22	undermine decades of progress in reducing youth tobacco use;
23	WHEREAS, a United States 2016 Surgeon General's report concluded that youth
24	use of nicotine in any form, including e-cigarettes, is unsafe, can cause addiction, and can
25	harm the developing adolescent brain; and
26	WHEREAS, A January 2018 report by the National Academies of Sciences,
27	Engineering and Medicine concluded, there is substantial evidence that e-cigarette use

- WHEREAS, the United States Food and Drug Administration is responsible for

- 5 NOW, THEREFORE,
- 6 Be it resolved by the Senate of the General Assembly of the Commonwealth of
- 7 Kentucky, the House of Representatives concurring therein:
- Section 1. The Senate in concurrence with the House of Representatives of the
- 9 General Assembly urges the United States Food and Drug Administration to implement
- 10 marketing restrictions on e-cigarettes.
- → Section 2. The Senate and House of Representatives of the Commonwealth
- 12 further urge the Food and Drug Administration to stop the sales of all flavored e-cigarette
- products that have not been subject to public health review by the Food and Drug
- 14 Administration as the law requires.
