1	A CONCURRENT RESOLUTION establishing the Public Water and Wastewater
2	System Infrastructure Task Force.
3	WHEREAS, water is a critical natural resource for Kentucky; and
4	WHEREAS, Kentucky's water infrastructure, including drinking water treatment
5	plants and distribution systems, wastewater treatment plants and collection systems, and
6	dams, is critical to Kentucky's public health and safety, economic development,
7	environmental sustainability, and quality of life; and
8	WHEREAS, there are approximately 450 public drinking water systems in
9	Kentucky that serve more than 95 percent of the population, and the majority of
10	Kentucky's citizens are connected to regional wastewater service; and
11	WHEREAS, these systems include municipalities, boards, associations, districts,
12	and investor-owned companies whose structure of governance and regulatory control
13	varies; and
14	WHEREAS, Kentucky's water infrastructure is extensive, and the average age of
15	Kentucky's water systems often exceeds the system's design life; and
16	WHEREAS, Kentucky has made significant progress to preserve and improve
17	access to potable water and adequate wastewater services through regionalization and
18	consolidation of water and wastewater systems; and
19	WHEREAS, the challenges for Kentucky's water and wastewater infrastructure are
20	system age; ongoing use of deferred maintenance; insufficient planning and infrastructure
21	investment; and a lack of technical, managerial and financial capacity, all of which have
22	resulted in water infrastructure failures; and
23	WHEREAS, absent preventive measures and some level of intervention, a failing
24	community public drinking water system is likely to become insolvent and put the
25	citizens of the Commonwealth in jeopardy of not having potable water; and
26	WHEREAS, the General Assembly should determine when and how to prevent the
27	failure of community water and wastewater systems and should empower the proper

- 3 NOW, THEREFORE,
- 4 Be it resolved by the Senate of the General Assembly of the Commonwealth of
- 5 Kentucky, the House of Representatives concurring therein:
- Section 1. The Legislative Research Commission is hereby directed to establish
- 7 the Public Water and Wastewater System Infrastructure Task Force to evaluate and
- 8 develop legislative recommendations and policy options on how to:
- 9 (1) Create an evaluation process that can identify community public drinking
- water systems and wastewater systems that lack technical, managerial, and financial
- 11 capacity and that may be at risk of failure;
- 12 (2) Identify and assess the current regulatory and enforcement authority of the
- oversight agencies and identify the policy and regulatory options to improve the
- sustainability and the technical, managerial, and financial capacity of community water
- and wastewater systems;
- 16 (3) Identify statutes that would need to be amended to implement policy options
- and any legal impediments to implementing specific policy options;
- 18 (4) Develop recommendations regarding the authority, procedures, and resources
- 19 necessary to intervene and prevent technical, managerial, or financial failure of
- 20 community water and wastewater systems; and
- 21 (5) Identify options for generating state and local funds that may be used to
- 22 directly fund water infrastructure projects and leverage other public and private funds.
- → Section 2. The task force shall have 21 members with the co-chairs of the
- committee selected by the President of the Senate and the Speaker of the House of
- 25 Representatives from the appointed legislative membership of their respective chambers.
- 26 The final membership of the task force, subject to the consideration and approval of the
- 27 Legislative Research Commission, shall be as follows:

- 21 (11) Two citizen members with experience in public drinking water systems with
- one being appointed by the Senate President and one being appointed by the Speaker of
- 23 the House of Representatives;
- 24 (12) The director of the Kentucky Resources Council or his or her designee;
- 25 (13) A representative of the Kentucky Rural Community Assistance Partnership
- submitted by the organization;
- 27 (14) A representative of the American Water Works Association submitted by the

- organization;
- 2 (15) A representative of an investor-owned utility that delivers water or wastewater
- 3 services;

- 4 (16) The president of the American Council of Engineering Companies of
- 5 Kentucky or his or her designee;
- 6 (17) The president of the Kentucky Chamber of Commerce of his or her designee;
- 7 and
- 8 (18) An operator representative of the Kentucky Water and Wastewater Operators
- 9 Association submitted by the organization.
- → Section 3. The task force shall meet when the General Assembly is not in
- session between the effective date of this Resolution and the date that it submits
- 12 legislative recommendations to the Legislative Research Commission. The staff from the
- 13 Division of Water in the Energy and Environment Cabinet may assist staff of the
- 14 Legislative Research Commission in the performance of duties associated with the task
- 15 force.
- Section 4. The task force may submit findings, legislative recommendations, or
- a memorandum to the Legislative Research Commission by December 15, 2019. If
- legislative recommendations are submitted, the Legislative Research Commission may
- 19 refer the recommendations to the appropriate committee or committees of jurisdiction by
- 20 December 20, 2019, in advance of the 2020 Regular Session of the Kentucky General
- 21 Assembly.
- 22 → Section 5. Provisions of this Resolution to the contrary notwithstanding, the
- 23 Legislative Research Commission shall have the authority to alternatively assign the
- 24 issues identified herein to an interim joint committee or subcommittee thereof and to
- 25 designate a study completion date.
