1	A RESOLUTION commending Taiwan for its relations with the United States and
2	the Commonwealth of Kentucky.
3	WHEREAS, on January 13, 2024, Taiwan completed another successful
4	presidential and legislative election; and
5	WHEREAS, Taiwan is the United States' ninth-largest trading partner, and the
6	United States is Taiwan's second-largest trading partner, with an estimated bilateral trade
7	amount of \$160 billion in 2022; and
8	WHEREAS, Kentucky's exports to Taiwan increased 62.6 percent between 2020
9	and 2021, and Kentucky's imports from Taiwan increased 49.2 percent between 2020 and
10	2021, making Taiwan Kentucky's eighteenth highest export country and thirteenth
11	highest import country; and
12	WHEREAS, the year 2024 marks the landmark 45th anniversary of the enactment
13	of the Taiwan Relations Act, which has facilitated an even closer partnership between the
14	United States and Taiwan in security, business, education, culture, and people-to-people
15	exchanges; and
16	WHEREAS, in 2023, Taiwan welcomed the largest number of United States
17	official delegations to date; and
18	WHEREAS, Kentucky became a bellwether of education after the launch of the
19	"U.STaiwan Education Initiative" in 2020, by signing the higher education and K-12
20	cooperation memoranda of understanding with Taiwan in 2021, facilitating more
21	Mandarin and English language exchanges between students and teachers; and
22	WHEREAS, under this memorandum of understanding, and thanks to the

WHEREAS, under this memorandum of understanding, and thanks to the cooperation between the Kentucky Department of Education and the Asia Institute Crane House, Taiwan welcomed nine English teachers to host a three-week English summer camp for 16 elementary and middle schools; and

WHEREAS, Kentucky welcomes all opportunities for an even closer partnership on
business, educational, cultural, and people-to-people exchanges between citizens of the

United States and Taiwan, and hopes to collaborate better together in the worldwide post pandemic economic recovery efforts; and

WHEREAS, Taiwan has been experiencing continuous threats from their authoritarian neighbor, China, which has encroached on Taiwan's security by launching multiple missiles and dispatching numerous aircraft and vessels into Taiwan's air defense identification zone and across the Taiwan Strait median line. China has also disseminated disinformation, launched cyberattacks, and repeatedly excluded Taiwan from the international system as demonstrated through its denial of Taiwan's participation in the United Nations system meetings, mechanisms, conventions, and activities; and

10 WHEREAS, in 2022, the United States and Taiwan saw a strengthening in bilateral 11 relations with the launch of the "U.S.-Taiwan Initiative on 21st-Century Trade," which 12 facilitates a roadmap for negotiations on economic and trade agreements with high-13 standard commitments; visits from numerous high-ranking elected officials amidst 14 China's provocation; the "National Defense Authorization Act for Fiscal Year 2023," 15 which facilitates a defense modernization program for Taiwan to deter China's 16 aggression; and the signing of the "Taiwan-U.S. Memorandum of Understanding on 17 Development and Humanitarian Assistance Cooperation," which highlights that Taiwan 18 is a significant stakeholder globally; and

WHEREAS, in June 2023, the United States and Taiwan signed the first agreement
 under the "US-Taiwan Initiative on 21st Century Trade," covering customs and border
 procedures, regulatory practices, and small business; and

WHEREAS, as a formal member of the Asia-Pacific Economic Cooperation (APEC) since 1991, Taiwan continues to make great contributions and is an indispensable key partner to the welfare of the people in the Asia-Pacific region;

Section 1. The Senate encourages the members of this body to join the Taiwan
Caucus in urging the Commonwealth of Kentucky to establish a trade office in Taiwan,
as North Carolina, South Carolina, Arizona, Virginia, West Virginia, and Pennsylvania
have recently done. The establishment of a trade office in Taiwan will attract more
investments in Taiwan and the Commonwealth and enable the Commonwealth's officials
and General Assembly members to conduct more frequent exchanges with their
Taiwanese counterparts.

8  $\rightarrow$  Section 2. The Senate supports the "US-Taiwan Initiative on 21st-Century 9 Trade" and the negotiations on the Bilateral Trade Agreement as Taiwanese companies 10 are looking for diverse and free markets in the United States instead of China, and further 11 supports Taiwan's meaningful participation in international organizations and 12 mechanisms such as the World Health Organization, United Nations Framework 13 Convention on Climate Change, International Civil Aviation Organization, International 14 Criminal Police Organization, Comprehensive and Progressive Agreement for Trans-15 Pacific Partnership, and Indo-Pacific Economic Framework for Prosperity.
