HEALTH CARE: (Constitutional Amendment) Provides relative to prohibiting mandatory participation in a health care system

A JOINT RESOLUTION

2	Proposing to add Article I, Section 28 of the Constitution of Louisiana, to prohibit
3	mandatory participation in a health care system; to provide for submission of the
4	proposed amendment to the electors; and to provide for related matters.
5	Section 1. Be it resolved by the Legislature of Louisiana, two-thirds of the members
6	elected to each house concurring, that there shall be submitted to the electors of the state of
7	Louisiana, for their approval or rejection in the manner provided by law, a proposal to add
8	Article I, Section 28 of the Constitution of Louisiana, to read as follows:
9	§28. Freedom to Choose Health Care
10	Section 28.(A) In order to preserve the freedom of all residents of Louisiana
11	to provide for their own health care, no law or rule shall compel, directly or
12	indirectly, any person, employer, or health care provider to participate in a health
13	care system.
14	(B)(1) A person or employer may pay directly for health care services and
15	shall not be required to pay penalties or fines for paying directly for lawful health
16	care services.
17	(2) A health care provider may accept direct payment for lawful health care
18	services and shall not be required to pay penalties or fines for accepting direct
19	payment from a person or employer for lawful health care services.

1 (C) The purchase or sale of health insurance in private health care systems 2 shall not be prohibited by law or rule. 3 Section 2. Be it further resolved that this proposed amendment shall be submitted 4 to the electors of the state of Louisiana at the statewide election to be held on November 4, 5 2014. 6 Section 3. Be it further resolved that on the official ballot to be used at the election. 7 there shall be printed a proposition, upon which the electors of the state shall be permitted 8 to vote YES or NO, to amend the Constitution of Louisiana, which proposition shall read as 9 follows: 10 Do you support an amendment to prohibit any law or administrative rule 11 from requiring any person, employer, or health care provider to participate 12 in a health care system? Hollis HB No. 429

Abstract: Prohibits any law or administrative rule from requiring any person, employer, or health care provider to participate in a health care system.

<u>Proposed constitutional amendment</u> prohibits a law or rule from compelling, directly or indirectly, any person, employer, or health care provider to participate in a health care system.

<u>Proposed constitutional amendment</u> authorizes a person or employer to pay directly for health care services and provides that the person or employer shall not be required to pay penalties or fines for paying directly for lawful health care services.

<u>Proposed constitutional amendment</u> authorizes a health care provider to accept direct payment for lawful health care services and provides that the health care provider shall not be required to pay penalties or fines for accepting direct payment from a person or employer for lawful health care services.

<u>Proposed constitutional amendment</u> provides that the purchase or sale of health insurance in private health care systems shall not be prohibited by law or rule.

Provides for submission of the proposed amendment to the voters at the statewide election to be held November 4, 2014.
