SCHOOLS/EMPLOYEES: Provides relative to suicide prevention in schools

2	To amend and reenact R.S. 17:282.4(C)(introductory paragraph) and 437.1 and to enact R.S.
3	17:282.4(F) and 3996(B)(54), relative to suicide prevention in schools; to provide
4	for training for school employees, to provide relative to services provided to
5	students; to provide relative to student identification cards; to provide for programs
6	and policies; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 17:282.4(C)(introductory paragraph) and 437.1 are hereby amended
9	and reenacted and R.S. 17:282.4(F) and 3996(B)(54) are hereby enacted to read as follows:
10	§282.4. Youth suicide prevention programs; policies; intent; rules; services; funding
11	* * *
12	C. Any city, parish, or other local public school system offering a youth
13	suicide prevention program established pursuant to this Section shall do so in
14	accordance with such rules and regulations adopted by the state board, and shall
15	report its participation to the state Department of Education. The department shall
16	designate such a school as a Suicide Prevention Certified School and maintain an

2	include but shall not be limited to the following:

10	§437.1. Suicide prevention; in-service training; materials and supplies; limitation
1	on liability
12	A. The State Board of Elementary and Secondary Education shall develop
13	and adopt guidelines for in-service training in suicide prevention as provided for in
14	Subsection B of this Section. The board, in coordination with the Louisiana
15	Department of Health, shall identify suitable materials programs for use in such
16	training. The state Department of Education shall post on its website a listing of
17	approved programs. The list shall include instructions on accessing such programs.
18	The board shall update the list every five years.
19	B.(1) The board shall adopt rules to require that all public and approved
20	nonpublic school teachers, school counselors, and principals and, as determined by
21	the board, other school administrators for whom such training is deemed beneficial
22	participate annually in at least two hours of in-service training in suicide prevention.
23	Such rules shall include provisions permitting such training to be provided by
24	self-review of suitable materials.
25	(2) The training shall address the following:
26	(a) Increasing awareness of risk factors including but not limited to the
27	following:
28	(i) Mental health and substance abuse conditions.
29	(ii) Childhood abuse, neglect, and trauma.

1	(iii) Potential causes of stress, such as bullying, harassment, and relationship
2	problems.
3	(iv) Secondary trauma from a suicide or sensationalized or graphic accounts
4	of suicide in media.
5	(v) History of suicide attempts and related family history.
6	(b) How teachers should respond to suspicious behavior or warning signs
7	exhibited by students.
8	(c) How teachers should respond to a crisis situation in which a student is an
9	imminent danger to himself.
10	(d) Policies and protocol for communication with parents, including
11	specifications for circumstances in which parental notification is not in the best
12	interest of the student.
13	(e) Counseling services available within the school for students and their
14	families related to suicide prevention.
15	(f) Dissemination of information concerning crisis intervention, suicide
16	prevention, and mental health services in the community for students and their
17	families and school employees.
18	(g) Community organizations and agencies for referral of students to health,
19	mental health, substance abuse, and social support services, including development
20	of at least one memorandum of understanding between the school system and such
21	an entity in the community or region.
22	C.(1) No person shall have a cause of action for any loss or damage caused
23	by any act or omission resulting from the implementation of or good faith attempt
24	to implement the provisions of this Section or resulting from any training, or lack
25	thereof; required by this Section, unless such loss or damage was caused by willful
26	or wanton misconduct.
27	(2) The training, or lack thereof, required by the provisions of this Section
28	shall not Neither the training required by this Section nor the lack thereof shall be
29	construed to impose any specific duty of care.

1	D.(1) The State Board of Elementary and Secondary Education shall
2	randomly survey employees of public and approved nonpublic secondary schools to
3	ascertain their compliance with the suicide prevention training requirements of this
4	Section.
5	(2) The governing authority of each such secondary school shall document
6	and verify to the state Department of Education, by December thirty-first of each
7	year, that all school employees have received the mandatory suicide prevention
8	training as outlined in this Section.
9	(3) The board shall annually develop a written report of the survey findings
10	and any recommendations and shall submit such report to the Senate Committee on
11	Education, the House Committee on Education, the Senate Committee on Health and
12	Welfare, and the House Committee on Health and Welfare not later than March first
13	of each year.
14	E. This Section shall be known and may be cited as the "Jason Flatt Act".

16	§3996. Charter schools; exemptions; requirements

18	B. Notwithstanding any state law, rule, or regulation to the contrary and
19	except as may be otherwise specifically provided for in an approved charter, a
20	charter school established and operated in accordance with the provisions of this
21	Chapter and its approved charter and the school's officers and employees shall be
22	exempt from all statutory mandates or other statutory requirements that are
23	applicable to public schools and to public school officers and employees except for
24	the following laws otherwise applicable to public schools with the same grades:

Abstract: Provides relative to requirements for youth suicide prevention, intervention, and postvention, in-service training for school employees, and services available to students.

<u>Present law</u> requires the State Bd. of Elementary and Secondary Education (BESE) to prescribe rules, collaboratively with the La. Dept. of Health (LDH) Adolescent Health Initiative, for a youth suicide prevention plan for public schools. Requires that such plan include procedures for development of suicide prevention programs by local school systems.

<u>Present law</u> requires local suicide prevention programs to comply with BESE regulations and provides relative to the content of such programs.

<u>Proposed law</u> retains <u>present law</u> and further requires schools offering youth suicide prevention programs to report such participation to the state Dept. of Education (DOE). Requires DOE to designate such a school as a Suicide Prevention Certified School and to maintain a list of such schools on its website.

<u>Proposed law</u> requires the governing authority of each public and approved nonpublic secondary school that issues student identification cards to have printed on the cards the phone numbers for the National Suicide Prevention Lifeline hotline number and, if available, a local suicide prevention hotline number.

<u>Proposed law</u> provides that <u>present law</u> and <u>proposed law</u> regarding suicide prevention programs are applicable to charter schools.

<u>Present law</u> requires BESE to adopt guidelines for in-service training of school employees in suicide prevention. Requires that the board adopt rules requiring public and approved nonpublic school employees to participate in at least two hours of such training annually.

Proposed law requires that such training address:

- (1) Increasing awareness of risk factors.
- (2) Employee response to suspicion, concerns, or warning signs exhibited by students and to crisis situations.
- (3) Policies and protocol for communication with parents.
- (4) Services available at the school and in the community.
- (5) Development of a plan to assist survivors.

<u>Proposed law</u> requires that the board identify suitable programs and requires coordination with LDH in identification of such programs. Requires DOE to post a list of approved programs on its website. Requires school employees to participate in such training, rather than requiring BESE to adopt rules to require such training.

<u>Present law</u> provides for immunity from liability for loss or damage caused by implementation of <u>present law</u> regarding in-service training. <u>Proposed law</u> further provides

for such immunity for loss or damage caused by a good faith attempt to implement <u>present</u> law and proposed law.

<u>Proposed law</u> requires BESE to randomly survey schools regarding compliance with requirements for in-service training and requires submission of a report on survey findings to the legislative education and health and welfare committees.

Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Education</u> to the original bill:

- 1. Require the United Way of Southwest La.'s teen text hotline be printed on the back of student identification cards instead of the National Suicide Prevention Lifeline hotline number, the Crisis Text Line number, and a local suicide prevention hotline number.
- 2. Make youth suicide prevention programs applicable to charter schools, instead of the identification card component.
- 3. Delete provision requiring all school employees to complete suicide prevention training and retain <u>present law</u> requiring employees as provided by rule to complete such training.
- 4. Add content requirements for suicide prevention in-service training. Remove such <u>proposed law</u> content requirements that would have been applicable to school governing authority policies.
- 5. Change requirement of frequency of BESE to survey schools on compliance with training requirements from annually to randomly.

The House Floor Amendments to the engrossed bill:

1. Require the National Suicide Prevention Lifeline hotline number and a local suicide prevention hotline number, if available, be printed on the back of student identification cards instead of the United Way of Southwest La.'s teen text hotline.
