APPROPRIATIONS/JUDGMENT: Appropriates funds for payment of certain consent judgments against the state through the Department of Transportation and Development

AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2023-3 2024 to be used to pay certain consent judgments rendered against the state, through 4 the Department of Transportation and Development, in the claims against the state 5 entitled Tharun Mittapalli versus U-Haul International, Inc., et al. Consolidated with 6 Tanika T. Adams, et al. versus U-Haul International, et al. Consolidated with Oscar 7 Floyd versus U-Haul International, et al. Consolidated with Vijaypal Reddy Keesara 8 et al. versus U-Haul International, et al. and Alexis Nezat versus Seth Matthews, et 9 al.; and to provide for related matters. 10 Be it enacted by the Legislature of Louisiana: 11 Section 1. 1 Section 2. Each judgment may only be paid from this appropriation if it is final and 2 shall be paid as to principal, interest, court costs, and expert witness fees as awarded in the 3 judgment. If the provisions of the judgment conflict with the provisions of this Act, the 4 provisions of the judgment shall be controlling. Any other provision of this Act not in 5 conflict with the provisions of the judgment shall control. Payment shall be made only after presentation to the state treasurer of documentation required by the state treasurer. Further, 6 7 each judgment shall be deemed to have been paid on the effective date of this Act, and 8 interest shall cease to run as of that date. 9 Section 3. This Act shall become effective upon signature by the governor or, if not 10 signed by the governor, upon expiration of the time for bills to become law without signature 11 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If vetoed by the governor and subsequently approved by the legislature, this Act shall become 12 13 effective on the day following such approval.
