- (2) Life skills.
- (3) Healthy choices.
- (4) Literacy instruction.

<u>Proposed law</u> provides that this program shall be administered by selected nonprofit groups as well as the Dept. of Public Safety and Corrections, the Dept. of Children and Family Services, the Dept. of Education, the La. Workforce Commission, and the Dept. of Veterans Affairs.
