Be it enacted by the Legislature of Louisiana:

Section 1. R.S. 13:996.6(A) is hereby amended and reenacted to read as follows:

§996.6. Judicial expense fund for Twenty-First Judicial District; established

A. In addition to all other fees or costs now or hereafter provided by law, the clerk of court of the Twenty-First Judicial District shall collect from every person filing any type of civil suit or proceeding and who is not otherwise exempted by law from the payment of court costs, a sum to be determined by the judges of said district, sitting en banc, which sum shall not exceed ten twenty dollars, subject, however, to the provisions of Louisiana Code of Civil Procedure, Article 5181, et seq. In all criminal cases over which the Twenty-First Judicial District Court has jurisdiction, there shall be taxed as costs against every defendant who is convicted after trial or after he pleads guilty or who forfeits his bond, a sum likewise determined, but which shall not exceed ten twenty dollars, which shall be in addition to all other fines, costs, or forfeitures lawfully imposed, and which shall be

Edwards HB No. 72

Abstract: Authorizes a \$10 increase for civil and criminal court costs to be allocated to the judicial expense fund for the 21st Judicial District Court.

<u>Present law</u> authorizes the judges of the 21st JDC to determine an amount of not more than \$10 to be collected by the clerk of court from every person filing any type of civil suit or proceeding.

<u>Present law</u> authorizes the judges of the 21st JDC to determine an amount of not more than \$10 to be collected in all criminal cases over which the 21st JDC has jurisdiction, from every defendant who is convicted after trial or after he pleads guilty or who forfeits his bond in addition to all other fines, costs or forfeitures lawfully imposed. <u>Present law</u> requires these costs to be transmitted to the clerk for distribution into the judicial expense fund for the 21st and 22nd JDC.

<u>Proposed law</u> retains <u>present law</u> except that it changes the amount authorized for collection by the clerk of court <u>from</u> an amount not to exceed \$10 to an amount not to exceed \$20.
