1 AN ACT

2 To amend and reenact R.S. 40:2707 and 2714(E) and (I), relative to tanning facilities; to  
3 prohibit the use of tanning equipment by persons under eighteen years of age; to  
4 provide for notice requirements; to make technical changes; and to provide for  
5 related matters.

6 Be it enacted by the Legislature of Louisiana:

7 Section 1. R.S. 40:2707 and 2714(E) and (I) are hereby amended and reenacted to  
8 read as follows:

9 §2707. Prohibited acts; advertisement; minors

10 A. A tanning facility ~~may~~ shall not claim or distribute promotional materials  
11 that claim use of a tanning device is safe or free from risk. No person shall state or  
12 imply that any activity under such registration has been approved by the department.

13 B. A tanning facility shall not allow any person under eighteen years of age  
14 to use any tanning equipment.

16 §2714. Information provided to consumer

18 ~~E. Before any person between fourteen and eighteen years of age uses a~~  
19 ~~tanning device, the tanning facility shall secure a statement signed at the tanning~~  
20 ~~facility by the person's parent or tutor stating that the parent or tutor has read and~~  
21 ~~understood the warnings given by the tanning facility, consents to the minor's use of~~  
22 ~~a tanning device, and agrees that the minor will use the protective eyewear that the~~

1           ~~tanning facility provides. A person under fourteen years of age shall be accompanied~~  
2           ~~by a parent or tutor when using a tanning device.~~ The registrant shall place, at the  
3           ~~entrance of the tanning facility, signage that states "LOUISIANA LAW PROHIBITS~~  
4           ~~PERSONS UNDER 18 YEARS OF AGE FROM USING ANY TANNING~~  
5           ~~FACILITY EQUIPMENT THAT EMITS ULTRAVIOLET LIGHT FOR THE~~  
6           ~~PURPOSE OF SKIN TANNING".~~ The signage shall have dimensions of at least  
7           ~~eight inches by ten inches.~~

9                     I. ~~Effective October 1, 1991, the~~ The registrant shall limit the operation of  
10           tanning equipment to persons who have successfully completed formal training  
11           courses ~~which~~ that cover the provisions of Subsection H of this Section and have  
12           been approved by the department.
