CURRICULA: Requests a study relative to allowing Anatomy and Physiology to count in addition to, rather than as a substitute for, Biology II for Taylor Opportunity Program for Students (TOPS) award qualification and high school graduation

## 2 To urge and request the Board of Regents and the State Board of Elementary and Secondary 3 Education to study collaboratively the feasibility and advisability of allowing 4 Anatomy and Physiology to count in addition to, rather than as a substitute for, 5 Biology II for purposes of satisfying requirements relative to qualification for Taylor 6 Opportunity Program for Students awards and high school graduation and submit 7 jointly a written report of findings and conclusions, including any recommendations 8 for related legislation, to the House Committee on Education and the Senate 9 Committee on Education not later than sixty days prior to the beginning of the 2020 10 Regular Session of the Legislature. 11 WHEREAS, the Constitution of Louisiana provides that it is the goal of the state's 12 public educational system to afford every individual an equal opportunity to develop to his full potential; and 13 14 WHEREAS, Anatomy and Physiology is a dynamic and challenging high school 15 course that provides an excellent foundation for students interested in pursuing further 16 studies and careers in scientific fields; and 17 WHEREAS, while Anatomy and Physiology has some similarities with Biology II, 18 they are distinct courses that do not completely overlap in terms of subject matter; some 19 students who are particularly interested in the topics covered in these courses would like the 20 option of taking both and having them both count for credit toward satisfying requirements

for high school graduation and Taylor Opportunity Program for Students (TOPS) award 2 qualification, but that is not currently an option; and 3 WHEREAS, in requirements for high school graduation, Biology II and Anatomy 4 and Physiology are grouped together in the same subset of science options, only one of 5 which can be taken for credit toward graduation; similarly, TOPS rules provide that 6 Anatomy and Physiology is an acceptable equivalent course for Biology II, which means that 7 if they are both taken, they cannot both "count" for purposes of TOPS; and 8 WHEREAS, graduation requirements are set in BESE policy, except for graduation 9 requirements for a career diploma, which are set in state law; TOPS core curricula 10 requirements are also provided in state law; thus, amendments of such laws should be 11 considered; and 12 WHEREAS, there has been a move in recent years to align high school graduation 13 requirements with TOPS core curricula requirements; thus, any revisions of these 14 requirements should be made in concert; and 15 WHEREAS, in order to fulfill the state's constitutional duty of affording every 16 student an equal opportunity to develop to his full potential, it is appropriate that the 17 feasibility and advisability of including Anatomy and Physiology as an option in addition 18 to, rather than a substitute for, Biology II receive a thorough evaluation. 19 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby 20 urge and request the Board of Regents and the State Board of Elementary and Secondary 21 Education to study collaboratively the feasibility and advisability of allowing Anatomy and 22 Physiology to count in addition to, rather than as a substitute for, Biology II for purposes of 23 satisfying requirements relative to qualification for Taylor Opportunity Program for Students 24 awards and high school graduation and submit jointly a written report of findings, 25 conclusions, and recommendations, including any recommendations for related legislation, 26 to the House Committee on Education and the Senate Committee on Education not later than 27 sixty days prior to the beginning of the 2020 Regular Session of the Legislature. 28 BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted 29 to the chairman of the Board of Regents and the president of the State Board of Elementary 30 and Secondary Education.
