HOUSE CONCURRENT STUDY REQUEST NO. 2

MEDICAID: Requests a study of the feasibility of the La. Children and Youth Health Insurance Program providing for reimbursement of health care services delivered at schools

1	A CONCURRENT STUDY REQUEST
2	To the House Committee on Health and Welfare and the Senate Committee on Health and
3	Welfare to meet and to function as a joint committee to study the feasibility of the
4	Louisiana Children and Youth Health Insurance Program funding school-based
5	health services and to report the findings of the joint committee to the legislature
6	prior to December 15, 2011.
7	WHEREAS, the Louisiana Children and Youth Health Insurance Program (LaCHIP)
8	is part of Louisiana's Medicaid program and is the largest provider of health insurance for
9	children of low-income families in this state; and
10	WHEREAS, LaCHIP ranks highly on a national basis among like programs in terms
11	of enrolling eligible families; and
12	WHEREAS, despite the success of LaCHIP in enrolling eligible families, health
13	outcomes for children in this state are among the worst in the nation; and
14	WHEREAS, Louisiana has poor outcomes not only in the physical health of children
15	but in children's mental health as well; and
16	WHEREAS, nurses in schools play a significant role in children's health care,
17	administering medications and referring children to physicians and mental health services;
18	and
19	WHEREAS, school systems have Medicare and Medicaid provider numbers and can
20	be reimbursed by these programs for services to eligible children; and

1	WHEREAS, Medicaid funds school-based health services presently but on a limited
2	basis, reimbursing school systems only for services rendered by nurses to disabled
3	Medicaid-eligible children who require nursing services as outlined in the Individualized
4	Education Plans (IEPs) of those children; and
5	WHEREAS, IEPs are required by federal law to ensure that children with disabilities
6	receive services necessary for academic success; and
7	WHEREAS, expanding Medicaid reimbursement for school-based health services
8	beyond a limited group of children with disabilities can greatly enhance overall medical care
9	in the setting where children spend most of their day; and
10	WHEREAS, strategic investments in children's health, such as expanding Medicaid
11	reimbursement for school-based health services, can produce a positive and sizeable fiscal
12	impact; and
13	WHEREAS, such positive fiscal impact can result from the prevention of chronic
14	diseases in childhood which diminish future adult productivity and are extremely costly to
15	treat.
16	THEREFORE, the Legislature of Louisiana requests the House Committee on Health
17	and Welfare and the Senate Committee on Health and Welfare to meet and to function as a
18	joint committee to study the feasibility of the Louisiana Children and Youth Health
19	Insurance Program funding school-based health services and to report the findings of the
20	joint committee to the legislature prior to December 15, 2011. The committees shall engage
21	the Department of Health and Hospitals and the Department of Children and Family Services
22	in developing the report, which shall provide information and data including but not limited
23	to statistics on annual expenditures of Medicaid funds for school-based health services
24	delivered in Louisiana for the previous five years, and a listing of all entities which have
25	received Medicaid reimbursement for school-based health services delivered in Louisiana
26	in the previous five years.

Harrison HCSR No. 2

Requests the House and Senate committees on health and welfare to jointly study the feasibility of LaCHIP funding school-based health services.

Requests that the committees report findings to the legislature prior to Dec. 15, 2011.

Directs the committees to engage the Dept. of Health and Hospitals and the Dept. of Children and Family Services in developing the report.

Requires that the report provide information and data including but not limited to statistics on annual expenditures of Medicaid funds for school-based health services delivered in La. for the previous five years, and a listing of all entities which have received Medicaid reimbursement for school-based health services delivered in La. in the previous five years.
