<u>Present law</u> creates the Ernest N. Morial-New Orleans Exhibition Hall Authority (convention center authority). The purpose of the convention center authority is to acquire, construct, reconstruct, extend, improve, maintain, and operate projects within the city of New Orleans in order to promote the economic growth and development of the city and its neighboring parishes.

<u>Present law</u> provides that except as otherwise provided, all persons who are appointed to the board must be residents of, or have their principal place of business in, the parish of Orleans, with the exception of two members who shall be a resident of or have their principal place of business in the state of Louisiana.

<u>Proposed law</u> changes <u>present law</u> so that all persons who are appointed to the board must be residents of, or have their principal place of business in, the state of Louisiana.

Effective upon signature of the governor or lapse of time for gubernatorial action.
