Appointees to the management board of any legal entity formed 10 pursuant to R.S. 17:3390, an executed memorandum of understanding, or any 11 other contract or agreement by the Board of Supervisors of Louisiana State University, the state of Louisiana, and the Administrators of the Tulane 12 13 Educational Fund, for the purpose of financing, constructing, or operating a public hospital or academic medical center in the city of New Orleans shall be 14 subject to confirmation by the Senate prior to being seated on the board of any 15 such legal entity. 16

specified in Subsection A of this Section.

Section 2. This Act shall become effective upon signature by the governor or, if not signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If vetoed by the governor and subsequently approved by the legislature, this Act shall become effective on the day following such approval.

Murray (SB 18)

<u>Proposed law</u> requires the appointees to the management board of any legal entity formed pursuant to <u>present law</u> (R.S. 17:3390), an executed memorandum of understanding, or any other contract or agreement by the Board of Supervisors of Louisiana State University, the state of Louisiana, and the Administrators of the Tulane Educational Fund, for the purpose of financing, constructing, or operating a public hospital or academic medical center in the city of New Orleans shall be subject to confirmation by the Senate prior to being seated on the board of any such legal entity. Subjects such entities to financial disclosure.

Effective upon signature of the governor or lapse of time for gubernatorial action.
