SPECIAL DISTRICTS. Provides for the city of St. George Transition District. (gov sig)

1	AN ACT
2	To enact Part IX-A of Chapter 6 of Title 33 of the Louisiana Revised Statutes of 1950, to be
3	comprised of R.S. 33:3121 through 3125, relative to government within East Baton
4	Rouge Parish; to provide for the continued collection of tax revenue to fund essential
5	public services within the city of St. George; to authorize the parish to continue
6	collection of a previously approved two percent sales and use tax and to continue
7	providing essential public services within the corporate limits of the city of St.
8	George pursuant to intergovernmental agreement; to create a St. George Transition
9	District as a taxing district to provide monies for essential public services within the
10	municipality; to provide for the board of directors of the district; to provide for the
11	duties, powers, and responsibilities of the district; to authorize the district to levy and
12	collect a sales and use tax not to exceed two percent; to provide time limits for the
13	continuation of such taxes; to authorize contracts, intergovernmental agreements, and
14	cooperative endeavors; and to provide for related matters.
15	Notice of intention to introduce this Act has been published.
16	Be it enacted by the Legislature of Louisiana:
17	Section 1. Part IX-A of Chapter 6 of Title 33 of the Louisiana Revised Statutes of

2	Part IX-A. St. George - Transition District
3	§3121. Legislative findings; purpose
4	The legislature hereby finds and determines that in the event the lawsuit
5	challenging the incorporation of the city of St. George within East Baton Rouge
6	Parish is unsuccessful, a state of emergency will exist in the municipality until
7	cash flow can be developed through the levy and collection of municipal sales
8	and use taxes to fund the expenses of municipal government. As a result of the
9	foregoing, the legislature determines it essential and necessary to authorize the
10	continuation of the parish tax within the area incorporated, to authorize the
11	continuation of the provision of services by the parish within the area
12	incorporated, and to create a financial assistance district and provide for it a
13	source of revenue in order that it may engage in cooperative endeavors, enter
14	into contracts for the provision of essential public services, and raise revenue
15	to assist the municipality in funding the delivery of essential public services to
16	its citizens and to assist the municipality in preventing cash flow difficulties.
17	§3122. Definitions
18	Whenever used in this Act, unless a different meaning clearly appears
19	in the context, the following terms, whether used in the singular or plural, shall
20	be given the following interpretations:
21	(1) "Board" means the board of directors of the district or any successor
22	thereto.
23	(2) "District" means the St. George Transition District or any successor
24	thereto.
25	(3) "Mayor-president" means the mayor-president of the city of Baton
26	Rouge and parish of East Baton Rouge.
27	(4) "Municipality" means the city of St. George in East Baton Rouge

3	(7) "Parish tax" means the two percent sales and use tax levied in the

5	§3123. Continued levy of tax by East Baton Rouge Parish
6	Notwithstanding any law to the contrary, in the event the incorporation
7	of the city of St. George as approved by the voters on October 12, 2019, is
8	declared incorporated, the parish may continue to levy and collect the parish
9	tax within the corporate limits of the municipality pursuant to an
10	intergovernmental agreement between the parish and municipality, for the
11	purpose of providing essential public services to, or funding essential public
12	services for, the citizens within St. George until the St. George Transition
13	District levies and collects a two percent sale and use tax, the municipality levies
14	and collects a two percent sales and use tax, the end of the quarter following the
15	election to impose the municipal tax if the proposition is not approved by the
16	electorate, or twelve months after the incorporation becomes final, whichever
17	<u>occurs first.</u>
18	§3124. St. George Transition District; sales tax
19	A. In furtherance of the purposes of this Part, the St. George Transition
20	District is hereby created as a special taxing district whose boundaries are
21	coterminous with the municipality, and it shall be a body politic and corporate
22	and a political subdivision of the state with all of the powers of a political
23	subdivision and with such further powers and functions as are set forth in this
24	Section. It is hereby determined that the creation of the district and the carrying
25	out of its public purpose is in all respects a public and governmental purpose for
26	the improvement of the health, safety, welfare, comfort, and security of the
27	people of the municipality, and that such purposes are public purposes, and that
28	the district will be performing an essential governmental function and meeting
29	a public obligation in the exercise of the powers conferred upon it by this

1	Section.
2	B.(1) The district shall be administered and governed by a board of
3	directors of five persons composed of:
4	(a) The mayor-president or his designee who shall be a registered voter
5	and living in the district.
6	(b) One member, who shall be a registered voter and living in the
7	district, appointed by the senator representing Senate District No. 6.
8	(c) One member, who shall be a registered voter and living in the
9	district, appointed by the member of the House of Representatives representing
10	House District No. 66.
11	(d) The chairman and vice chairman for the petition for incorporation
12	of St. George or their designees.
13	(2) The appointed members shall be selected on the basis of their
14	experience in management and relevant knowledge and ability to act effectively
15	for the best interests of the municipality.
16	(3) The board shall elect one of its members as chairman and another
17	as treasurer. The board shall appoint a secretary and such other officers as are
18	deemed necessary who need not be directors of the district.
19	(4)(a) A majority of the directors shall constitute a quorum, and a
20	majority vote of the directors constituting the quorum shall be necessary for
21	any action taken by the district. No vacancy on the board shall impair the right
22	of a quorum to exercise all of the rights and perform all of the duties of the
23	district.
24	(b) Any vacancy which occurs prior to expiration of the term for which
25	a member of the board has been appointed shall be filled for the remainder of
26	the unexpired term in the same manner as the original appointment. Board
27	members shall be eligible for reappointment.
28	(c) Notwithstanding the provision of Subparagraph (b) of this Paragraph
29	to the contrary, if the appointing authority fails to make an appointment within

1	twenty days of the date of a vacancy, the remaining appointed members may
2	appoint an individual who signed the petition to incorporate the city of St.
3	George for the remainder of the unexpired term.
4	(5) The board shall fix the place or places at which meetings shall be
5	held. The domicile of the district shall be within the parish.
6	(6) The members of the board shall serve without salary or per diem
7	allowance.
8	C. The district shall have all of the rights and powers necessary to carry
9	out and effectuate the purposes and provisions of this Part. The district shall be
10	subject to the laws pertaining to open meetings, public records, official journals,
11	dual office holding and employment, and the Code of Governmental Ethics.
12	Without limiting the generality of the foregoing, the district shall have the
13	following rights and powers:
14	(1) To adopt bylaws and prescribe rules for the regulation of its affairs
15	and the conduct of its business.
16	(2) To adopt an official seal and alter the same at its pleasure.
17	(3) To maintain an office within the parish at such place as it may
18	designate.
19	(4) To sue and be sued.
20	(5) To receive, administer, and comply with the conditions and
21	requirements respecting any gift, grant, or donation of any property or money.
22	(6) To apply and contract for assistance from the United States or other
23	public or private sources, whether in the form of a grant or loan or otherwise.
24	(7) To make and execute contracts, intergovernmental agreements, and
25	other instruments necessary in the exercise of the powers and functions of the
26	district under this Part, including contracts with persons, firms, corporations,
27	and others.
28	(8) To pledge or assign any contracts or rights of the district.
29	(9) To employ such personnel as may be required in the judgment of the

1	board and to fix and pay their compensation from funds available to the district
2	therefor.
3	(10) To transfer, grant, or donate all or any portion of its revenues to the
4	municipality in order to assist the municipality in funding the delivery of
5	essential public services to its citizens, reducing or eliminating its cash flow
6	deficits or remedying cash flow shortfalls, paying obligations in connection
7	therewith, or any combination of these.
8	(11) To accept the mortgage, pledge, hypothecation, assignment, grant,
9	or donation of any properties of the municipality.
10	(12) To invest its monies in accordance with R.S. 33:2955.
11	(13) To enter into cooperative endeavor agreements or contracts for the
12	provision of staff and meeting facilities and for the provision of such assistance
13	and such essential public services as the district may require in carrying out the
14	intents and purposes of this Part.
15	(14) To incur debt.
16	(15) To exercise any and all other powers necessary to accomplish the
17	purposes set forth in this Part.
18	D.(1) In order to provide funds for the purpose of assisting the
19	municipality to fund the delivery of essential public services to its citizens,
20	reduce or eliminate its cash flow deficit or remedy cash flow shortfalls, pay
21	obligations in connection therewith, or any combination of these, the district is
22	hereby authorized to levy and collect a sales and use tax not to exceed two
23	percent. However, the district shall not levy or collect a tax if the rate thereof,
24	when combined with the rate of the municipal sales and use taxes collected
25	within the municipality, exceeds two percent.
26	(2) The tax shall be imposed by the district without the need of an
27	election and shall be levied upon the sale at retail, the use, the lease or rental,
28	the distribution, the consumption, and the storage for use or consumption of
29	tangible personal property, and on sales of services in the state, as presently

1	defined in and as provided by Chapter 2 of Subtitle II of Title 47 of the
2	Louisiana Revised Statutes of 1950, subject to the tax exemptions provided in
3	Chapter 2 of Subtitle II of Title 47 of the Louisiana Revised Statutes of 1950.
4	Notwithstanding any provision of law to the contrary, the levy of the tax shall
5	be effective and the tax shall be payable beginning on such date as shall be
6	provided by the district.
7	(3) The proceeds of the tax shall be irrevocably pledged and dedicated
8	and shall be transferred in such amounts as may be determined by the district
9	to assist the municipality in funding the delivery of essential public services to
10	its citizens, reducing or eliminating its cash flow deficit, remedying cash flow
11	shortfalls, paying obligations in connection therewith, or any combination of
12	these.
13	(4) The district shall contract with the parish for the collection of the tax
14	under such terms and conditions applicable to other entities within the parish.
15	(5) The provisions of this Section shall be void, the district shall cease
16	existence, and any sales and use taxes levied by the district shall expire at such
17	time as the municipality levies and collects a two percent sales and use tax, the
18	end of the quarter following the election to impose the municipal tax if the
19	proposition is not approved by the electorate, or twelve months after the
20	incorporation becomes final, whichever occurs first.
21	§3125. Liberal construction
22	This Part does and shall be construed to provide a complete method for
23	the doing of the things authorized by this Part. The provisions of this Part shall
24	be liberally construed for the accomplishment of its purposes.
25	Section 2. This Act shall become effective upon signature by the governor or, if not
26	signed by the governor, upon expiration of the time for bills to become law without signature
27	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
28	vetoed by the governor and subsequently approved by the legislature, this Act shall become
29	effective on the day following such approval.

<u>Proposed law</u>, relative to the city of St. George in East Baton Rouge Parish, provides for transition following incorporation, as follows:

- (1) Provides legislative findings and determinations that in the event the suit challenging incorporation of the city of St. George is unsuccessful, a state of emergency will exist until cash flow can be developed through the levy and collection of municipal sales and use taxes to fund the expenses of municipal government and that it is essential and necessary to authorize the continuation of current sales and use taxes levied by the parish and the provision of services by the parish within the incorporated area and to create a financial assistance district and provide a source of revenue for it so it may engage in cooperative endeavors, contract for the provision of essential public services, and raise revenue to assist the municipality in funding essential public services and preventing cash flow difficulties.
- (2) Defines terms for purposes of <u>proposed law</u>:
 - (a) Board the board of directors of the district or any successor thereto.
 - (b) District the city of St. George Transition District or any successor thereto.
 - (c) Mayor-president the mayor-president of the city of Baton Rouge and parish of East Baton Rouge.
 - (d) Municipality city of St. George in East Baton Rouge Parish.
 - (e) Municipal tax the 2% sales and use tax levied by the city of St. George.
 - (f) Parish East Baton Rouge Parish.
 - (g) Parish tax the 2% sales and use tax levied by the city of St. George.
- (3) Provides that in the event the city of St. George is declared incorporated, the parish may continue to levy and collect the parish tax within the corporate limits of the municipality pursuant to an intergovernmental agreement between the parish and municipality. The continuation shall be for the purpose of providing essential public services to, or funding essential public services for, the citizens within St. George. The collection shall continue until such time as any one of the following occurs: the St. George Transition District levies and collects a two percent sale and use tax; the municipality levies and collects a two percent sales and use tax; the end of the quarter following the election to impose the municipal tax if the proposition is not approved by the electorate; or twelve months after the incorporation becomes final.
- (4) Creates the city of St. George Transition District as a special taxing district with boundaries coterminous with the municipality. Provides that the district is a body politic and corporate and a political subdivision of the state with all of the powers of a political subdivision. Provides that the legislature determines that the creation of the district and the carrying out of its public purpose is a public and governmental purpose for the improvement of the health, safety, welfare, comfort, and security of the people of the municipality, that such purposes are public purposes, and that the district will be performing an essential governmental function and meeting a public

obligation in the exercise of the powers conferred upon it by proposed law.

Provides that the district shall be administered and governed by a five-member board of directors:

- (a) The mayor-president or his designee who shall be a registered voter and living in the district.
- (b) One member, who shall be a registered voter and living in the district, appointed by the senator representing Senate District No. 6.
- (c) One member, who shall be a registered voter and living in the district, appointed by the House member representing House District No. 66.
- (d) The chairman and vice-chairman for the incorporation petition for the city of St. George or their designees.

Requires that the appointed members be selected on the basis of experience in management, knowledge, and ability to act effectively for the best interests of the municipality.

Requires the board to elect one member as chairman and another as treasurer and to appoint a secretary and such other officers as it deems necessary who need not be board members.

Provides that a majority of the members constitutes a quorum and requires a majority vote of the quorum to take action. Provides that a vacancy shall not impair the right of a quorum to exercise all of the rights and perform all of the duties of the district. Requires that the district's domicile be in the parish.

Provides that members serve without salary or per diem.

Provides that if the appointing authority fails to make an appointment within 20 days of the date of vacancy, the remaining appointed members may appoint an individual who signed the petition to incorporate the city of St. George for the remainder of the unexpired term.

(5) Grants the district all of the rights and powers necessary to carry out and effectuate the purposes and provisions of <u>proposed law</u>. Provides that the district is subject to the laws pertaining to open meetings, public records, official journals, dual office holding and employment, and the Code of Governmental Ethics.

Specifically grants the district certain rights and powers, including:

- (a) To receive, administer, and comply with the conditions and requirements respecting any gift, grant, or donation of any property or money.
- (b) To apply and contract for assistance from public or private sources.
- (c) To make and execute contracts, intergovernmental agreements, and other instruments necessary in the exercise of its powers and functions.
- (d) To pledge or assign any contracts or rights of the district.
- (e) To employ personnel the board deems to be required and to fix and pay their compensation from funds available therefor.
- (f) To transfer, grant, or donate all or any portion of its revenues to the

municipality to assist in funding essential public services, reducing or eliminating its cash flow deficits or remedying cash flow shortfalls, paying obligations in connection therewith, or any combination of these.

- (g) To accept the mortgage, pledge, hypothecation, assignment, grant, or donation of any properties of the municipality.
- (h) To invest its monies in accordance with <u>present law</u> (R.S. 33:2955) relative to investments by political subdivisions.
- (i) To enter into cooperative endeavor agreements or contracts for the provision of staff and meeting facilities and for the provision of such assistance and such essential public services as the district may require in carrying out the intents and purposes of <u>proposed law</u>.
- (j) To incur debt.
- (k) To exercise any and all other powers necessary to accomplish the purposes of proposed law.
- (6) Authorizes the district to levy and collect a 2% sales tax to provide funds to assist the municipality to fund essential public services, reduce or eliminate its cash flow deficit or remedy cash flow shortfalls, pay obligations in connection therewith, or any combination of these. Prohibits such levy if the rate of such tax, when combined with the rate of the municipal sales and use taxes collected within the municipality, exceeds 2%.

Provides for levy of the tax by district ordinance without the need for an election, in accordance with <u>present law</u> relative to sales taxes. Provides that the tax levy shall be effective and the tax shall be payable beginning on such date as provided by the district.

Requires that tax proceeds are irrevocably pledged and dedicated and shall be transferred in such amounts as may be determined by the district to assist the municipality in funding essential public services, reducing or eliminating its cash flow deficit, remedying cash flow shortfalls, paying obligations in connection therewith, or any combination of these. Requires the district to contract with the parish for tax collection under such terms and conditions applicable to other entities within the parish and authorizes board rules regarding enforcement and collection of the tax.

Provides that <u>proposed law</u> relative to the city of St. George Transition District and its powers and duties shall be void, that the district shall cease existence, and that any sales tax levied by the district shall expire when the earliest of the following occurs:

- (a) The municipality levies and collects a 2% sales tax;
- (b) The end of the quarter following the election to impose the municipal tax, if the proposition is not approved by the electorate; or
- (c) 12 months after the incorporation becomes final.
- (7) Provides that <u>proposed law</u> is to be construed to provide a complete method for the doing of the things it authorizes and that its provisions shall be liberally construed for the accomplishment of its purposes.

Effective upon signature of the governor or lapse of time for gubernatorial action.

Summary of Amendments Adopted by Senate

<u>Committee Amendments Proposed by Senate Committee on Local and Municipal</u> <u>Affairs to the original bill</u>

- 1. Changes the triggering mechanism of the bill <u>from</u> the incorporation of the city of St. George to a determination that the suit challenging that incorporation is unsuccessful and the city of St. George is declared incorporated.
- 2. The district may enter into an intergovernmental agreement between the parish and municipality for the providing of essential public services to, or funding essential public services.
- 3. Changes the appointing authorities for the board of directors <u>from</u> the senator representing District No. 16 to the senator representing District No. 6 and <u>from</u> the chairpersons to the chairman and vice chairman.
- 4. Changes the time frame for which the appointed authority must make an appointment in the event of a vacancy from 60 days to 20 days.
- 5. Removes provisions that held district liable for the parish's outstanding debt secured by the parish taxes incurred before the date of incorporation and unfunded liabilities of the parish.
- 6. Makes technical changes.
