| 11 | B. The commissioner of administration may, with the approval of the Joint |
| 12 | Legislative Committee on the Budget, incorporate into the new fiscal year's |
| 13 | appropriation any appropriations from the prior fiscal year against which bona fide |
| 14 | obligations existed on the last day of the fiscal year. No transactions shall be |
| 15 | approved in this manner after the forty-fifth day following the last day of the fiscal |
| 16 | year; provided, however, that in any year in which the Joint Legislative |
| 17 | Committee on the Budget is unable to meet to approve the transactions before |
| 18 | the forty-fifth day following the last day of the fiscal year due to a declared |
| 19 | disaster or emergency, the transactions shall be placed on the agenda of the next |
| 20 | Joint Legislative Committee on the Budget meeting for approval and may be |
| 21 | approved after the forty-fifth day following the last day of the fiscal year. |
| 22 | However, the next meeting shall take place no later than thirty days after the |
| 22 | end of the declared disaster or emergency. |
