1	A JOINT RESOLUTION
2	Proposing to amend Article VII, Section 27(B)(1) of the Constitution of Louisiana, relative
3	to the Transportation Trust Fund; to remove authority to appropriate or dedicate
4	monies in the trust fund to state police for traffic control purposes; and to specify an
5	election for submission of the proposition to electors and provide a ballot
6	proposition.
7	Section 1. Be it resolved by the Legislature of Louisiana, two-thirds of the members
8	elected to each house concurring, that there shall be submitted to the electors of the state, for
9	their approval or rejection in the manner provided by law, a proposal to amend Article VII,
10	Section 27(B)(1) of the Constitution of Louisiana, to read as follows:
11	§27. Transportation Trust Fund
12	Section 27. * * * *
13	(B)(1) Except as provided for in Subparagraph (2) of this Paragraph, the
14	monies in the trust fund shall be appropriated or dedicated solely and exclusively for
15	the costs for and associated with construction and maintenance of the roads and
16	bridges of the state and federal highway systems, the Statewide Flood-Control
17	Program or its successor, ports, airports, transit, state police for traffic control
18	purposes, and the Parish Transportation Fund or its successor and for the payment
19	of all principal, interest, premium, if any, and other obligations incident to the
20	issuance, security, and payment in respect of bonds or other obligations payable from
21	the trust fund as authorized in Paragraph (D) hereof of this Section. Unless pledged
22	to the repayment of bonds authorized in Paragraphs (C) or (D) of this Section, the
23	monies in the trust fund allocated to ports, airports, flood control, parish
24	transportation, and state highway construction shall be appropriated annually by the

1	legislature only pursuant to programs established by law which establish a system
2	of priorities for the expenditure of such monies, except that the Transportation
3	Infrastructure Model for Economic Development, which shall include only those
4	projects enumerated in House Bill 17 of the 1989 First Extraordinary Session of the
5	Legislature and US Highway 61 from Thompson Creek to the Mississippi Line, in
6	lieu of "US 61-Bains to Mississippi Line", and US Highway 165 from I-10 to
7	Alexandria to Monroe to Bastrop and thence on US Highway 425 from Bastrop to
8	the Arkansas Line, in lieu of "US 165-I-10 Alexandria-Monroe-Bastrop-Arkansas
9	Line" and LA 15-Natchez, Mississippi to Chase in lieu of "LA 15-Natchez,
10	Mississippi to Monroe", shall be funded as provided by law. The state generated
11	state-generated tax monies appropriated for ports, Parish Transportation Fund, or
12	its successor, and the Statewide Flood-Control Program, or its successor, and state
13	police for traffic control purposes shall not exceed twenty percent annually of the
14	state generated state-generated tax revenues in the trust fund; provided, however,
15	that no less than the avails of one cent of the tax on gasoline and special fuels shall
16	be appropriated each year to the Parish Transportation Fund, or its successor. The
17	annual appropriation for airports shall be a sum equal to, but not greater than, the
18	annual estimated revenue to be derived from the state taxes to be collected and
19	received on aviation fuel. Unencumbered and unexpended balances at the end of
20	each fiscal year shall remain in the trust fund. The earnings realized in each fiscal
21	year on the investment of monies in the trust fund shall be deposited in and credited
22	to the trust fund.

Section 2. Be it further resolved that this proposed amendment shall be submitted
to the electors of the state of Louisiana at the statewide election to be held on November 6,
2018.

27 Section 3. Be it further resolved that on the official ballot to be used at said election 28 there shall be printed a proposition, upon which the electors of the state shall be permitted 29 to vote YES or NO, to amend the Constitution of Louisiana, which proposition shall read as 30 follows:
