The Commonwealth of Massachusetts

**In the One Hundred and Ninety-First General Court
(2019-2020)**

An Act relating to liability protection for disaster volunteers.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 1: Chapter 112 of the general laws, as appearing in the 2018 Official Edition, is
2 hereby amended by adding the following sections:-

3 Section 12C ½:-

4 Whereas licensed registered nurses are critical, necessary volunteers in disasters and
5 emergencies occurring in the commonwealth, in order to provide for community need, as
6 volunteers they require protection from the commonwealth for licensure board discipline; for
7 civil and/or criminal liability and/or prosecution for injury or harm caused to a patient cared for
8 while serving as a volunteer; and for protection from injury or harm he/she personally suffers
9 during the course or as a result of his/her volunteer service.;

10 Section 12 C ½ (a) As used in this section, the following words, shall, unless the context
11 clearly requires otherwise, have the following meanings:-

12 “Disaster”, an emergency detrimental to the public health declared by the governor of the
13 commonwealth of Massachusetts under section 2A of Chapter 17; a state of emergency declared
14 by the governor under chapter 639 of the Acts of 1950 (“Civil Defense Act”); and/or a public
15 health incident where local public health authorities have issued a request for volunteers because
16 local resources have been or are expected to be exhausted or are insufficient.

17 “Patient”, an individual who receives health services from a licensed registered nurse
18 during a declared disaster or emergency.

19 “Volunteer”, a licensed registered nurse in good standing who volunteers his or her
20 services in a disaster or emergency without compensation or expectation of payment.

21 Section 12 C ½ (b) Exemption from licensure discipline and civil and criminal liability

22 12 C ½ (b) A registered nurse licensed in the commonwealth of Massachusetts with no
23 encumbrance on his or her license who provides oversight or direct care to patients who are
24 victims of a disaster or emergency declared by the governor of the commonwealth of
25 Massachusetts or local public health authorities is not subject to licensure board discipline under
26 sections 74 to 81C of chapter 112 of the general laws, or to civil or criminal liability or
27 prosecution for any injury or harm that results from any act or omission that does not amount to
28 criminal negligence:

29 Section 12 C ½ (c) Volunteer protection from harm

30 12 C ½ (c) A volunteer as defined in 12 C ½ (a) who sustains injury, disability or who
31 dies while serving as a volunteer shall be construed to be an employee of the commonwealth and

32 shall be compensated in like manner as state employees are compensated under the provisions of
33 sections 69 through 75 of chapter 152 of the general laws.
