By Mr. Naughton of Clinton, a petition (accompanied by bill, House, No. 4075) of Harold P. Naughton, Jr. and others (by vote of the town) for legislation to authorize the conveyance of a certain parcel of land in the town of Northborough. Municipalities and Regional Government. [Local Approval Received.]

The Commonwealth of Massachusetts

In the Year Two Thousand Twelve

An Act Authorizing the Town of Northborough to Convey Certain Parklands to Abutters.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. The town of Northborough, acting by and through its board of selectmen, may
2 transfer 2 parcels of land, being portions of land owned by the town of Northborough and held
3 for playground purposes from the parks and recreation commission to the board of selectmen for
4 the purpose of conveyance. The land is described in a deed to the town dated January 5, 1989
5 recorded in the Worcester south district registry of deeds in book 12219, page 366. The parcels
6 to be conveyed are shown as “Parcel C-2” and “Parcel C-3” on a plan entitled “Plan of Land in
7 Northborough, Massachusetts, Owned by the Town of Northborough, Scale 1”=40’, Date:
8 February 17, 2009, Prepared by R.W. Hart Associates, Inc., Northborough, Massachusetts,
9 Registered Land Surveyors & Engineers”.

10 SECTION 2. The town of Northborough, acting by and through its board of selectmen, may
11 convey the first parcel of land containing approximately 3,678 square feet, shown as “Parcel C-

12 2” on the plan referenced in section 1, to abutters, Robert A. DiGregorio and Joyce DiGregorio
13 of 72 Valentine road in the town, being the site of an existing pool and appurtenant buildings.
14 The consideration paid to the town for such conveyance shall be in the amount of \$ 6,215.82.
15 The town, acting by and through its board of selectmen, may convey the second parcel of land
16 containing approximately 3,680 square feet, shown as “Parcel C-3” on the plan referenced in said
17 section 1, to abutters, Andrew D.W. McKie and Susan E. McKie of 68 Valentine road in said
18 town, being the site of an existing driveway. The consideration paid to the town for such
19 conveyance shall be in the amount of \$6,219.20. The remainder of the property shown on such
20 plan, approximately 3.1274 acres, shall continue to be held for playground purposes under the
21 parks and recreation commission of the town of Northborough.

22 SECTION 3. This act shall take effect upon its passage.
