In the One Hundred and Ninetieth General Court

An Act relative to amending chapter 413 of the Acts of 1991 authorizing the city council of the city of Cambridge to amend chapter 14.04 of the Cambridge municipal code entitled "Fair Housing".

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. The City Council of the City of Cambridge is hereby authorized to amend  
2 Chapter 14.04.010 through Chapter 14.04.090 of the Cambridge Municipal Code entitled "Fair

16           Add “as amended” at the end of the sentence.

17           14.04.030 Definitions.

18           14.04.030 A In the third line replace the word “handicaps” with the word “disabilities”.

19           14.04.030 D In the fourth line add the words “gender identity” after the words “sexual

20 orientation”.

21           14.04.030 F Delete the definition of Disability and replace with the following:

22 "Disability" means a physical or mental impairment which substantially limits one or more of a

23 person’s major life activities, a record of having such impairment, or being regarded as having

24 such impairment. This term does not include current, illegal use of or addiction to a controlled

25 substance as defined in Section 102 of the Controlled Substances Act [21 USC 802]”.

26           14.04.030 G In the third line add the words “gender identity” after the words “sexual

27 orientation”.

28           14.04.030 K Delete the language in 14.04.030 K and replace with the following: “Gender  
29 identity” means a person’s gender-related identity, appearance or behavior, whether or not that  
30 gender-related identity, appearance or behavior is different from that traditionally associated with  
31 the person’s physiology or assigned sex at birth”.

32           14.04.040 Unlawful practices.

33           14.04.040 A.1 In the fifth line add the words “gender identity” after the words “sexual  
34 orientation”.

35           14.04.040 A.1b. In the seventh line add the words “gender identity” after the words  
36 “sexual orientation”.

56 “person with a disability”.

57           14.04.040 B. 3 b.ii In the second line replace the words “handicapped person” with  
58 “person with a disability”.

59           14.04.040 B.3 b.iii In the seventh line replace the words” “Buildings and Facilities  
60 providing Accessibility and Usability for Physically Handicapped people [“ANSI A117.1”]”  
61 with the following: “Accessible and Usable Buildings and Facilities [“ANSI’s ICC A117.1-  
62 2017”]”.

63           14.04.040 C.3 In the fourth and fifth lines replace the words “the handicapped “with  
64 “persons with disabilities” and in the seventh line add the words “gender identity” after the  
65 words “sexual orientation”.

66           14.04.040 C.4 In the second line replace the words “the handicapped with “persons or  
67 persons with disabilities” and in the fourth line add the words “gender identity” after the words  
68 “sexual orientation”.

69           14.04.050 Complaint Procedures

70           14.04.050 D In the fifth line replace the word “commission” with the word “Commission

71           14.04.050 E In the second line add the words “or her” after the words “or him”.

72           14.04.050 J In the second line add the words “or hers” after the words “or his”.

73           14.04.090 Severability

74           14.04.090 In the first line replace the word “It” with the word “If”.

75           SECTION 3. This act shall take effect upon its passage.
