AMENDMENT NO. 1

In Senator Hough's Amendments (SB0198/973420/1), in line 1 of Amendment No. 1, strike "<u>establishing</u>" and substitute "<u>prohibiting the Department of Agriculture from</u> <u>limiting the use of certain pesticides in a certain manner; requiring the Department to</u> <u>incorporate certain practices into a certain pollinator protection plan; requiring the</u> <u>Department to study and make recommendations regarding certain matters; requiring</u> <u>the Department to report its findings and recommendations to the Governor and the</u> <u>General Assembly within a certain period of time after the publication of a certain</u> <u>pollinator risk assessment; establishing</u>"; and in lines 2 and 3, strike "<u>5-2A-03</u>" and substitute "<u>5-2A-05</u>".

AMENDMENT NO. 2

In Senator Hough's Amendments, after line 2 of Amendment No. 2, insert:

"<u>The Department shall incorporate pollinator habitat</u> <u>expansion and enhancement practices into the State's Managed</u> <u>Pollinator Protection Plan developed in coordination with the U.S.</u> <u>Environmental Protection Agency.</u>
