### **Report of the Conference Committee on HB 101**

### The Capital Budget Bill

March 27, 2019

Mr. President,

Mr. Speaker,

Ladies and Gentlemen of the General Assembly of Maryland:

The report of the Conference Committee on HB 101 – the Maryland Consolidated Capital Bond Loan of 2019 is submitted for your review.

The House adopted 77 amendments to the original bill. The Senate adopted 94 committee amendments to the bill as amended by the House. The House rejected all of the Senate amendments and called for a Conference Committee. The Senate refused to recede and agreed to a Conference Committee. The Conference Committee worked to reconcile the differences between the House and Senate versions of the bill.

#### **Action of the Conference Committee:**

The Conference Committee recommends the authorization of \$1.085 billion in new State debt. Moreover, the Conference Committee recommends:
