8 (2) REIMBURSEMENT UNDER PARAGRAPH (1) OF THIS SUBSECTION 9 SHALL OCCUR NOT LATER THAN 6 MONTHS AFTER THE ELIGIBLE COUNTY SUBMITS 10 PAID INVOICES TO THE INTERAGENCY COMMISSION FOR REIMBURSEMENT.
