## A BILL ENTITLED

1 AN ACT concerning

2 **Department of the Environment – End-of-Life Management of Mattresses –**  
3 **Study**

4 FOR the purpose of requiring the Department of the Environment to study, identify, and  
5 make recommendations regarding certain matters that relate to the  
6 end-of-life management of mattresses in the State; requiring the Department to  
7 consult with certain State agencies and certain persons in carrying out certain  
8 activities; requiring the Department to report its findings and recommendations to  
9 the Governor and certain committees of the General Assembly on or before a certain  
10 date; and generally relating to the end-of-life management of mattresses.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
12 That:

13 (a) The Department of the Environment shall:

14 (1) study the end-of-life management of mattresses in the State, including  
15 further examination of the State's objectives regarding mattresses that are identified in  
16 Maryland's Zero Waste Plan;

17 (2) study the laws, regulations, and programs of other states governing the  
18 end-of-life management of mattresses, including states identified as having mattress  
19 extended producer responsibility programs by the Department of Legislative Services in its  
20 January 2017 study on solid waste management and recycling in Maryland;

21 (3) study the feasibility of implementing a mattress recycling program in  
22 the State, including the feasibility of implementing an extended producer responsibility  
23 program for mattresses in the State;

1 (4) identify local government programs in the State that provide for the  
2 end-of-life management of mattresses;

3 (5) identify for-profit and not-for-profit entities that can, with minimal  
4 State funding, facilitate the end-of-life management of mattresses in the State;

5 (6) recommend how a mattress recycling program can be used to facilitate  
6 goals for full employment in the State, including the creation of jobs for homeless  
7 individuals, disadvantaged youth, individuals with disabilities, and individuals who were  
8 incarcerated in a local, State, or federal correctional facility;

9 (7) recommend goals for reducing the number of mattresses going into  
10 landfills in the State over a defined period of time; and

11 (8) recommend measures to promote the end-of-life management of  
12 mattresses in the State, including measures to reduce the number of mattresses going into  
13 landfills in the State.

14 (b) In conducting the activities required under subsection (a) of this section, the  
15 Department shall consult with:

16 (1) the Department of Commerce;

17 (2) the Department of Labor, Licensing, and Regulation;

18 (3) the Maryland Environmental Service;

19 (4) representatives of local government; and

20 (5) representatives of for-profit and not-for-profit entities that have  
21 expertise with the end-of-life management of mattresses.

22 (c) On or before December 31, 2017, the Department shall report its findings and  
23 recommendations to the Governor and, in accordance with § 2-1246 of the State  
24 Government Article, the Senate Education, Health, and Environmental Affairs Committee  
25 and the House Environment and Transportation Committee.

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June  
27 1, 2017.
