## Baltimore County Circuit Court - Criminal Proceedings Court Webcast - Pilot Program

- 4 FOR the purpose of establishing for certain criminal proceedings in the Circuit Court for 5 Baltimore County a certain exception to the prohibition against recording or 6 broadcasting a criminal matter; providing for the application and scope of this Act; 7 requiring a certain presiding judge to ensure that a certain webcast does not include 8 certain matters; requiring the Circuit Court for Baltimore County to webcast in a 9 certain manner certain criminal proceedings; requiring the Circuit Court for Baltimore County to provide certain equipment; prohibiting a person from 10 11 broadcasting or otherwise disseminating certain portions of a court webcast under 12 certain circumstances; providing that a person who violates a certain provision of 13 this Act may be held in contempt of court; defining certain terms; providing for the termination of this Act; and generally relating to court webcasts of certain criminal 14 proceedings by the Circuit Court for Baltimore County. 15

  EXPRESS WRITTEN PERMISSION OF:
