## State Board of Waterworks and Waste Systems Operators – Fee Setting, Sunset Extension, and Program Evaluation

- FOR the purpose of requiring the State Board of Waterworks and Waste Systems Operators 4 5 to set certain fees so as to produce funds sufficient to cover certain costs of regulating 6 waterworks, wastewater works, and industrial wastewater works in accordance with 7 certain provisions of law; continuing the Board in accordance with the Maryland 8 Program Evaluation Act (sunset law) by extending to a certain date the termination 9 provisions relating to statutory and regulatory authority of the Board; requiring that an evaluation of the Board and the statutes and regulations that relate to the Board 10 11 be performed on or before a certain date; and generally relating to the State Board 12 of Waterworks and Waste Systems Operators.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

## 3 Article – Environment

- 4 12-206.
- 5 (a) (1) The Board [may] SHALL set reasonable fees for the issuance and 6 renewal of certificates and its other services.
- 7 (2) The fees [charged may] SHALL be set so as to produce funds [to 8 approximate the cost of maintaining the Board] SUFFICIENT TO COVER THE ACTUAL 9 DIRECT AND INDIRECT COSTS OF REGULATING WATERWORKS, WASTEWATER 10 WORKS, AND INDUSTRIAL WASTEWATER WORKS IN ACCORDANCE WITH THE 11 PROVISIONS OF THIS TITLE.
- 12 (b) In accordance with the State budget, the Board may pay expenses incurred in 13 carrying out the provisions of this title.
- 14 (c) The Board shall pay all funds collected under this section into the General 15 Fund of this State.

- Subject to the evaluation and reestablishment provisions of the Program Evaluation
  Act, and except for the rules and regulations adopted by the Secretary, this title shall
  terminate and be of no effect after July 1, [2021] **2031**.

- 24 (1) conduct a preliminary evaluation of each governmental activity or unit 25 to be evaluated under this section; and
