SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

## 3 Article - Natural Resources

- 4 10-410.
- 5 (a) (1) Except as otherwise provided in this subsection, a person may not hunt 6 any game bird or mammal on Sundays.
- 7 (2) The following persons may hunt the specified game birds and mammals 8 on Sundays:
- 9 (iv) Subject to the provisions of § 10–411 of this subtitle, in Calvert,
- 10 Caroline, Carroll, Charles, Harford, Queen Anne's, Somerset, [Talbot,] Wicomico, and
- 11 Worcester counties, a person hunting deer on private property with a bow and arrow or
- 12 crossbow during open season on the last three Sundays in October and the second Sunday
- in November;
- 14 (12) (i) This paragraph applies only in Dorchester County.
- 15 (ii) Subject to §§ 10–411 and 10–415 of this subtitle, the Department
- 16 may allow a person to hunt deer on private property on the second and third Sunday of the
- 17 deer firearms season.
- 18 (iii) [Subject to §§ 10–411 and 10–415 of this subtitle, the
- 19 Department may allow a person to hunt deer on private property on a Sunday during the
- 20 bow hunting season from the first Sunday in October through the second Sunday in
- 21 January the following year, inclusive.
- 22 (iv)] Subject to §§ 10–411 and 10–415 of this subtitle, the Department
- 23 may allow a person to hunt deer on private property on a Sunday during the deer muzzle
- 24 loader season.
- 25 (15) (I) THIS PARAGRAPH APPLIES ONLY IN DORCHESTER COUNTY
- 26 AND TALBOT COUNTY.
- 27 (II) SUBJECT TO §§ 10–411 AND 10–415 OF THIS SUBTITLE, THE
- 28 DEPARTMENT MAY ALLOW A PERSON TO HUNT DEER ON PRIVATE PROPERTY ON A
- 29 SUNDAY DURING THE BOW HUNTING SEASON FROM THE FIRST SUNDAY IN OCTOBER
- 30 THROUGH THE SECOND SUNDAY IN JANUARY THE FOLLOWING YEAR, INCLUSIVE.
- 31 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
- 32 1, 2020.
