HOUSE BILL 1216

(a) In this subtitle the following words have the meanings indicated.

2 (E) "QUALIFIED APPLICANT" MEANS AN AGRICULTURAL PRODUCER, A 3 NONPROFIT ORGANIZATION, OR AN INSTITUTION OF HIGHER EDUCATION THAT 4 MEETS THE QUALIFICATIONS ESTABLISHED IN § 2–2004 OF THIS SUBTITLE.

[(e)] (F) "Urban agricultural producer" means any person that annually sells, or
normally would have sold, \$1,000 or more of farm products in [Baltimore City] AN URBAN
AREA.

8 (G) "URBAN AREA" MEANS AN AREA OF THE STATE THAT IS DELINEATED AS 9 AN URBAN AREA BY THE U.S. CENSUS BUREAU.

10 2-2002.

11 (a) There is an Urban Agriculture Grant Program in the Department.

12 (b) The purpose of the Program is to increase the viability of urban farming and 13 improve access to urban–grown foods.

14 2-2003.

15 (a) There is an Urban Agriculture Grant Fund.

16 (b) The purpose of the Fund is to provide grants to [nonprofit organizations in 17 Baltimore City] **QUALIFIED APPLICANTS** to implement the Program.

18 (c) The Secretary shall administer the Fund.

19 (d) (1) The Fund is a special, nonlapsing fund that is not subject to § 7–302 of 20 the State Finance and Procurement Article.

21 (2) The State Treasurer shall hold the Fund separately, and the 22 Comptroller shall account for the Fund.

- 23 (e) The Fund consists of:
- 24 (1) Money appropriated to the Fund under subsection (g) of this section; 25 and

26 (2) Any other money from any other source accepted for the benefit of the 27 Fund.

28 (f) In accordance with this subsection, the Fund shall be used to provide grants 29 to [nonprofit organizations that: HOUSE BILL 1216

5 (vi) [Require] FOR NONPROFIT ORGANIZATIONS THAT RECEIVE 6 A GRANT FOR THE PURPOSE OF DISTRIBUTING GRANT MONEY TO URBAN 7 AGRICULTURAL PRODUCERS, REQUIRE at least [70%] 85% of the amount of each grant 8 to be distributed to [minority-owned or operated] urban agricultural producers LOCATED 9 IN LOW-INCOME CENSUS TRACTS OR DESIGNATED FOOD DESERTS, OF WHICH AT 10 LEAST 25% OF THE GRANT MONEY SHALL BE DISTRIBUTED TO URBAN 11 AGRICULTURAL PRODUCERS IN BALTIMORE CITY; and

the Department shall submit a report to the Governor and, in accordance with § 2–1257 of
the State Government Article, the Senate Budget and Taxation Committee and the House
Appropriations Committee on the effectiveness of the funding provided under this section.

(a) A nonprofit organization OR AN INSTITUTION OF HIGHER EDUCATION is
 qualified to receive a grant in accordance with this subtitle if the Department determines
 [that the nonprofit organization]:

- (1) [Is] WITH RESPECT TO A NONPROFIT ORGANIZATION, THAT THE
 NONPROFIT ORGANIZATION IS incorporated or maintains its principal place of business
 in [Baltimore City] AN URBAN AREA; [and]
- 28 (2) [Works] **THAT THE ENTITY WORKS** to increase the viability of urban 29 farming and improve access to urban–grown foods; **AND**

30 (3) THAT THE ENTITY WILL PROVIDE DIRECT TRAINING AND 31 ONGOING TECHNICAL ASSISTANCE, IN ACCORDANCE WITH A PROGRAM THAT IS 32 CERTIFIED BY THE U.S. DEPARTMENT OF AGRICULTURE OR THE DEPARTMENT, TO 33 URBAN AGRICULTURAL PRODUCERS THAT RECEIVE A GRANT UNDER THIS 34 SUBTITLE. 1 (B) AN URBAN AGRICULTURAL PRODUCER IS QUALIFIED TO RECEIVE A 2 GRANT IN ACCORDANCE WITH THIS SUBTITLE IF THE DEPARTMENT DETERMINES 3 THAT THE URBAN AGRICULTURAL PRODUCER WILL COMPLETE:

4 (1) NEW FARMING TRAINING OR CONTINUING EDUCATION UNDER A 5 PROGRAM THAT IS CERTIFIED BY THE U.S. DEPARTMENT OF AGRICULTURE OR THE 6 DEPARTMENT; AND

7 (2) 100 CONTACT HOURS DURING THE GRANT PERIOD TO PROVIDE 8 EDUCATION AND TRAINING RELATED TO URBAN AGRICULTURE TO ELEMENTARY 9 STUDENTS AND ELEMENTARY SCHOOLS.

10 [(b)] (C) Within 90 days after the end of a grant cycle, a qualified nonprofit 11 organization that received a grant in accordance with this subtitle shall submit a report to 12 the Department that includes the following information:

13 (1) The names and locations of urban agricultural producers that received
 14 funds under the Program;

15 (2) The dollar amount of funds awarded to each urban agricultural 16 producer; and

17 (3) The impact of the Program on increasing the viability of urban farming 18 and improving access to urban–grown foods.

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 20 October 1, 2022.
