## 2 Pilot Program - Alleged Rape, Sexual Offense, or Child Sexual Abuse - HIV 3 Postexposure Prophylaxis

FOR the purpose of establishing the Pilot Program for Preventing HIV Infection for Rape Victims; establishing the purpose of the pilot program; requiring the Governor's Office of Crime Control and Prevention to administer the pilot program; requiring that a victim of an alleged rape or sexual offense or a victim of alleged child sexual abuse be provided with a full course of treatment and follow-up care for postexposure prophylaxis for the prevention of HIV infection at the request of the victim and as prescribed by a health care provider; authorizing a victim who receives treatment under a certain provision of this Act to decline to provide certain information under certain circumstances; requiring the physician, qualified health care provider, or hospital providing a victim with certain treatment to inform the victim of a certain right; requiring that the treatment and follow-up care be provided without charge to the victim under certain circumstances; providing that the physician, qualified health care provider, or hospital providing the treatment or follow-up care is entitled to be paid by the Criminal Injuries Compensation Board under certain circumstances; providing for a certain immunity for certain persons; requiring the Governor's Office of Crime Control and Prevention to report to the Governor and General Assembly on or before a certain date; defining certain terms; providing for the termination of this Act; and generally relating to the Pilot Program for Preventing HIV Infection for Rape Victims.

- 1 (2) (I) A VICTIM WHO RECEIVES TREATMENT UNDER THIS
  2 SUBSECTION MAY DECLINE TO PROVIDE HEALTH INSURANCE INFORMATION OR
  3 SUBMIT PERSONAL INFORMATION TO A PAYMENT ASSISTANCE PROGRAM IF THE
  4 VICTIM BELIEVES THAT PROVIDING THE INFORMATION WOULD INTERFERE WITH
  5 PERSONAL PRIVACY OR SAFETY.
- 6 (II) THE PHYSICIAN, QUALIFIED HEALTH CARE PROVIDER, OR
  7 HOSPITAL PROVIDING A VICTIM WITH TREATMENT AND FOLLOW-UP CARE UNDER
  8 PARAGRAPH (1) OF THIS SUBSECTION SHALL INFORM THE VICTIM OF THE VICTIM'S
  9 RIGHT TO DECLINE TO PROVIDE HEALTH INSURANCE INFORMATION OR SUBMIT
  10 PERSONAL INFORMATION TO A PAYMENT ASSISTANCE PROGRAM.
- 11 (III) IF A VICTIM DECLINES TO PROVIDE HEALTH INSURANCE 12 INFORMATION OR TO SUBMIT PERSONAL INFORMATION TO A PAYMENT ASSISTANCE 13 PROGRAM:
- 14 THE TREATMENT AND FOLLOW-UP CARE SHALL BE PROVIDED WITHOUT CHARGE TO THE VICTIM; AND
- 2. THE PHYSICIAN, QUALIFIED HEALTH CARE PROVIDER, OR HOSPITAL PROVIDING THE TREATMENT OR FOLLOW-UP CARE IS ENTITLED TO BE PAID BY THE CRIMINAL INJURIES COMPENSATION BOARD AS PROVIDED UNDER SUBTITLE 8 OF THIS TITLE FOR THE COSTS OF PROVIDING THE SERVICES.
- 21 (D) (1) A PHYSICIAN OR A QUALIFIED HEALTH CARE PROVIDER WHO
  22 EXAMINES A VICTIM OF ALLEGED CHILD SEXUAL ABUSE UNDER THE PROVISIONS OF
  23 THIS SECTION IS IMMUNE FROM CIVIL LIABILITY THAT MAY RESULT FROM THE
  24 FAILURE OF THE PHYSICIAN OR QUALIFIED HEALTH CARE PROVIDER TO OBTAIN
  25 CONSENT FROM THE CHILD'S PARENT, GUARDIAN, OR CUSTODIAN FOR THE

- 27 **(2)** THE IMMUNITY PROVIDED UNDER PARAGRAPH **(1)** OF THIS 28 SUBSECTION EXTENDS TO:
- 29 (I) ANY HOSPITAL WITH WHICH THE PHYSICIAN OR QUALIFIED 30 HEALTH CARE PROVIDER IS AFFILIATED OR TO WHICH THE CHILD IS BROUGHT; AND
- 31 (II) ANY INDIVIDUAL WORKING UNDER THE CONTROL OR 32 SUPERVISION OF THE HOSPITAL.

- 5 (2) THE NUMBER OF PATIENTS THAT CHOSE TO RECEIVE 6 POSTEXPOSURE PROPHYLAXIS;
- 7 (3) THE TOTAL AMOUNT REIMBURSED TO PROVIDERS FOR THE 8 POSTEXPOSURE PROPHYLAXIS; AND
- 9 (4) THE COST OF THE POSTEXPOSURE PROPHYLAXIS TREATMENT 10 AND FOLLOW-UP CARE PROVIDED UNDER THE PILOT PROGRAM.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2019. It shall remain effective for a period of 3 years and, at the end of September 30, 2022, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
