## A BILL ENTITLED

#### 1 AN ACT concerning

# Baltimore County Board of Education – Legal Counsel and Chief Budget Analyst

- 4 FOR the purpose of authorizing the Baltimore County Board of Education to retain counsel  $\mathbf{5}$ in certain legal matters; requiring the Baltimore County Board of Education to 6 employ legal counsel and a Chief Budget Analyst; providing for the terms of 7 employment and salary of the legal counsel and Chief Budget Analyst; requiring the 8 legal counsel to serve as the legal advisor to the County Board; requiring the Chief 9 Budget Analyst to review the County Board's budget and approve or return the budget with suggested changes; requiring the Chief Budget Analyst to ensure that 10 11 education spending is in accordance with the County Board's budget; making a 12conforming change; and generally relating to staff for the Baltimore County Board of Education. 13

(D) THE BALTIMORE COUNTY BOARD MAY NOT SUBMIT ITS BUDGET TO THE
 BALTIMORE COUNTY COUNCIL UNDER § 5–102 OF THIS ARTICLE UNTIL IT HAS BEEN
 APPROVED BY THE CHIEF BUDGET ANALYST.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July1, 2020.
