- 21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

- 25 (a) (1) In this section the following words have the meanings indicated.

$\frac{1}{2}$	(2) "Applicant" means the individual, partnership, corporation, or other legal entity whose signature appears on the building permit application.
$\frac{3}{4}$	(3) (i) "Building" means a structure with exterior walls which combine to form an occupiable structure.
$5 \\ 6$	(ii) "Building" does not include a temporary structure, as defined in the Howard County Building Code.
7 8	(4) (i) "New construction" means construction of a building which requires a Howard County building permit.
9 10 11 12 13	(ii) "New construction" does not include, if the building replaces an existing building, replacement of a building due to casualty or loss within 3 years of that casualty or loss, or replacement of a mobile home on a site, except to the extent the gross square footage of the replacement building or replacement mobile home exceeds the gross square footage of the building or mobile home being replaced.
14	(5) "Occupiable" means space that is:

17	(ii) Equipped with means of egress, light, and ventilation.
18 19	(6) (i) "Residential" means a building that contains one or more dwelling units and includes a boarding house.

22	(iii) "Residential" does not include:

$28 \\ 29$	(b) The County Council by ordinance shall impose a school facilities surcharge on residential new construction for which a building permit is issued on or after July 1, 2004.
$\frac{30}{31}$	(c) (1) (I) [For] SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, FOR fiscal year [2005] 2020 AND EACH SUCCEEDING FISCAL YEAR, a school facilities

10 (II) THE COUNTY COUNCIL MAY NOT IMPOSE A SCHOOL 11 FACILITIES SURCHARGE ON RESIDENTIAL NEW CONSTRUCTION THAT IS CLASSIFIED 12 AS SENIOR HOUSING AND AN AFFORDABLE HOUSING UNIT, AS DEFINED IN § 28.116 13 OF THE COUNTY CODE.

14 **[**(2) For fiscal year 2006 and each succeeding fiscal year, the facilities 15 surcharge established in paragraph (1) of this subsection shall be adjusted for inflation in 16 accordance with the Consumer Price Index for All Urban Consumers published by the 17 United States Department of Labor, for the fiscal year preceding the year for which the 18 amount is being calculated.]

19 20	(2) The school facilities surcharge may not be construed to be a settlement cost.

24 25 26 27 28 29	(2) If, on completion, the residential new construction is not sold but the property is occupied by the applicant or the immediate family of the applicant, the county shall rebate to the applicant the school facilities surcharge imposed under this section if the initial assessment value assigned to the property by the State Department of Assessments and Taxation for purposes of the county real property tax equates to a market value that is less than \$200,000.

6 (f) Payment of the school facilities surcharge does not eliminate any authority to 7 apply any test concerning the adequacy of school facilities under the county's adequate 8 public school facility ordinance.

9 (g) Revenue collected under the school facilities surcharge shall be deposited in a 10 separate account and may only be used to pay for:

11 (1) Additional or expanded public school facilities such as renovations to 12 existing school buildings or other systemic changes; or

13 (2) Debt service on bonds issued for additional or expanded public school 14 facilities or new school construction.

15 (h) Revenue collected under the school facilities surcharge is intended to 16 supplement funding for public school facilities and may not supplant other county or State 17 funding for school construction.

(i) (1) The County Executive of Howard County shall prepare an annual
 report on the school facilities surcharge on or before August 31 of each year for the County
 Council of Howard County, the Howard County Senate Delegation, and the Howard County
 House Delegation, to include:
