# Health – Youth Camps – Application Fees for Certification

- FOR the purpose of prohibiting the Secretary of Health and Mental Hygiene from
  imposing a certain application fee for a youth camp certificate or letter of
  compliance that is greater than a certain fee imposed by the Secretary before
  the publication of certain fees in the Maryland Register on certain dates;
  prohibiting a certain regulation from taking effect until the General Assembly
  takes certain action; and generally relating to application fees for the
  certification of youth camps.

(a) (1) In addition to the powers set forth elsewhere in this article and
subject to the provisions of Title 10 of the State Government Article, on or before
October 1, 1987, the Secretary shall adopt regulations for certifying youth camps and
for issuing letters of compliance.

(2) (i) An applicant for a certificate shall submit an application to
 the Department on the form that the Secretary requires.
