## A BILL ENTITLED

1 AN ACT concerning

2 **Regulated Firearms – License Issued by Delaware, Pennsylvania, Virginia, or**  
3 **West Virginia – Reciprocity**

4 FOR the purpose of specifying that a license issued by Delaware, Pennsylvania,  
5 Virginia, or West Virginia to an individual to carry a regulated firearm,  
6 including a concealed regulated firearm, is valid in Maryland; and generally  
7 relating to regulated firearms.

8 BY repealing and reenacting, without amendments,  
9 Article – Public Safety  
10 Section 5–101(p)  
11 Annotated Code of Maryland  
12 (2011 Replacement Volume and 2012 Supplement)

13 BY adding to  
14 Article – Public Safety  
15 Section 5–303.1  
16 Annotated Code of Maryland  
17 (2011 Replacement Volume and 2012 Supplement)

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article – Public Safety**

21 5–101.

22 (p) “Regulated firearm” means:

4 **A LICENSE ISSUED BY DELAWARE, PENNSYLVANIA, VIRGINIA, OR WEST**  
5 **VIRGINIA TO AN INDIVIDUAL TO CARRY A REGULATED FIREARM, INCLUDING A**  
6 **CONCEALED REGULATED FIREARM, IS VALID IN THIS STATE.**

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
8 October 1, 2013.
