- 3 FOR the purpose of repealing certain provisions allowing certain individuals under the age

- 11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND.
- 12 That the Laws of Maryland read as follows:
- 13 Article Family Law
- 14 2–301.
- 15 **(**(a) An individual 16 or 17 years old may not marry unless:
- 16 (1) the individual has the consent of a parent or guardian and the parent
- or guardian swears that the individual is at least 16 years old; or
- 18 (2) if the individual does not have the consent of a parent or guardian,
- 19 either party to be married gives the clerk a certificate from a licensed physician, licensed

- 5 (1) the individual has the consent of a parent or guardian; and
- 6 (2) either party to be married gives the clerk a certificate from a licensed 7 physician, licensed physician assistant, or certified nurse practitioner stating that the 8 physician, physician assistant, or nurse practitioner has examined the woman to be 9 married and has found that she is pregnant or has given birth to a child.

- 12 (e) Until a license becomes effective, a clerk may not disclose the fact that an application for a license has been made [except to the parent or guardian of a party to be married].

- 16 (a) The clerk for the county in which a marriage ceremony is to be performed may 17 issue and deliver a license at the time the application is made.
- 18 (b) A license may be issued only at the office of the clerk during regular office 19 hours.
- 20 (c) **[**(1) If either party to be married is known to be of an age where the parental or guardian's consent and oath, or the licensed physician's certificate, required by § 2–301 of this title, is required, the clerk shall obtain the consent and oath or the certificate before issuing the license.
- 24 (2) (i) The clerk's record required under this title shall include:
- 25 1. the consent and oath required by § 2–301 of this title, if 26 written; or
- 27 2. the fact that consent was given and an oath was made, if given and made in person.
- 29 (ii) The licensed physician's certificate required by § 2–301 of this 30 title may not be made a part of the clerk's record.

Except on order of the court, the licensed physician's certificate shall 2 remain sealed. 3 Except as provided in paragraph (2) of this subsection, a license is not (d) 4 effective until 6 a.m. on the second calendar day after the license is issued. 5 For good cause shown, a judge of the circuit court for the county in 6 which the application is made may sign an authorization for a license to become effective 7 at a time before the waiting period expires, as stated in the authorization, if 1 of the parties 8 to be married is: 9 (i) a resident of this State; or 10 (ii) a member of the United States armed forces. 11 [(e)] **(D)** If, during the questioning of an applicant for a license, the clerk finds 12 that there is a legal reason why the applicants should not be married, the clerk shall 13 withhold the license unless ordered by the court to issue the license. 14 [(f)] **(E)** A license may be delivered personally or by mail to: either of the parties to be married; or 15 (1) 16 (2) any person authorized in writing by either of the parties to accept 17 delivery. 18 [(g)] **(F)** The Maryland Department of Health shall provide to each clerk: (1) 19 birth control information: and (i) 20 a list of the family planning clinics located in the county where (ii) 21 the license is issued. When the clerk issues a license, the clerk shall make the information 22(2)23and list available to each applicant for a license. [(h)] (G) 24 (1) A clerk may not predate an application for a license. 25A clerk who violates any provision of this subsection is guilty of a 26 misdemeanor and on conviction is subject: 27(i) for a first offense, to a fine not exceeding \$100; and
