1 (2) "Farm area motor vehicle" means a motor vehicle owned by a farmer 2 and operated only on a farm or on a highway within a 25–mile radius of the farm.

3 (f) In applying for registration of a farm area motor vehicle under this section, 4 the owner of the vehicle shall submit with the application, from the most recent federal tax 5 filing of the owner, a copy of:
