# Montgomery County - Alcoholic Beverages - Community Performing Arts Facility Special Event Permit

 $\mathbf{5}$ FOR the purpose of establishing in Montgomery County a community performing arts 6 facility special event permit; specifying that only a holder of a community performing arts facility license may obtain a community performing arts facility special event 7 8 permit; specifying the scope and annual fee for the community performing arts 9 facility special event permit; requiring a permit holder to provide certain notice to the Montgomery County Board of License Commissioners before a certain special 10 11 event; authorizing a permit holder to hold an unlimited number of events in a year; and generally relating to community performing arts facilities in Montgomery 1213 County.

- 24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 25 That the Laws of Maryland read as follows:

25 - 102.1  $\mathbf{2}$ This title applies only in Montgomery County. 25 - 1004.3 There is a BWL Community Performing Arts Facility license. 4 (a)  $\mathbf{5}$ (b)(1)The Board may issue the license for use by a nonprofit partnership, 6 limited liability company, corporation, or other entity that owns or leases a performing arts 7 facility that: 8 is used for art classes, banquets, community-related activities, (i) 9 exhibits, live performances, shows, theater productions, visual art shows, and weddings; 10 and 11 (ii) has: a minimum capacity of 200 individuals; and 121. 13 2.a maximum capacity of 1,499 individuals. 14 (2)The Board may not issue more than three licenses to a nonprofit 15partnership, limited liability company, corporation, or other entity that owns or leases performing arts facilities in separate locations. 16 17The license authorizes the license holder to sell beer, wine, and liquor (c) (1)by the drink from one or more outlets on the licensed premises for on-premises 18 19consumption. 20The Board may impose conditions on the issuance or renewal of the (2)21license that establish the areas in the community performing arts facility where beer, wine, 22and liquor may be sold, served, possessed, or consumed. 23(3)The license holder shall ensure that food is provided during the hours 24beer, wine, and liquor are sold, served, possessed, or consumed. 25(d) The holder of a Class B–BWLHR license with catering authority, a local (1)26caterer's license, or a State caterer's license may bring alcoholic beverages and food on the 27licensed premises under the terms of a contract with a holder of a BWL Community Performing Arts Facility license. 2829(2)A violation of this title that occurs when a caterer brings alcoholic 30 beverages on licensed premises as provided under paragraph (1) of this subsection is the

31 responsibility of the caterer and is not the responsibility of the license holder.

1 (e) The license holder may sell beer, wine, and liquor from 9 a.m. on any day of 2 the week to 2 a.m. the following day.

3 (f) The license may not be transferred to another location.

4 (g) The annual license fee is \$750.

5 (H) (1) THERE IS A COMMUNITY PERFORMING ARTS FACILITY SPECIAL 6 EVENT PERMIT.

7 (2) THE BOARD MAY ISSUE THE PERMIT ONLY TO THE HOLDER OF A 8 BWL COMMUNITY PERFORMING ARTS FACILITY LICENSE.

9 (3) A HOLDER OF THE PERMIT MAY SELL BEER, WINE, OR LIQUOR FOR 10 CONSUMPTION ON THE PREMISES OF THE SPECIAL EVENT.

11(4)A HOLDER OF THE PERMIT SHALL NOTIFY THE BOARD IN WRITING12ON A FORM PROVIDED BY THE BOARD AT LEAST 14 DAYS BEFORE EACH EVENT.

13(5)A HOLDER OF THE PERMIT MAY HOLD AN UNLIMITED NUMBER OF14EVENTS IN A YEAR.

15 (6) THE ANNUAL PERMIT FEE IS \$200.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July1, 2019.
