State Grants and Contracts – Reimbursement of Nonprofit Indirect Costs – Application

FOR the purpose of applying a certain provision of law related to the reimbursement of
indirect costs incurred by certain nonprofit organizations to certain grants and
contracts; providing that a certain provision of law does not require the
reimbursement of indirect costs incurred under certain grants and contracts during
any fiscal year that began before a certain date; making a stylistic change; and
generally relating to the reimbursement of indirect costs incurred by nonprofit
organizations.

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 That the Laws of Maryland read as follows:

20 (a) (1) In this section the following words have the meanings indicated.

21 (2) "Indirect costs" means any costs that would be considered to be indirect 22 costs under OMB Uniform Guidance.

23 (3) "Nonprofit organization" means an organization that is tax exempt 24 under § 501(c)(3), (4), or (6) of the Internal Revenue Code.

- (B) (1) THIS SECTION APPLIES ONLY TO:

6 (I) A GRANT OR CONTRACT AWARDED ON OR AFTER OCTOBER 7 1, 2018;

8 (II) A MULTI-YEAR GRANT OR CONTRACT AWARDED BEFORE 9 OCTOBER 1, 2018, IF:

- 10 **1.** THE GRANT OR CONTRACT CONTINUES TO BE IN 11 EFFECT ON OR AFTER OCTOBER 1, 2018; AND
- 122.FUNDING FOR THE GRANT OR CONTRACT IS13REQUIRED TO BE AUTHORIZED SEPARATELY FOR EACH FISCAL YEAR; AND

14(III) AN EXTENSION OR A RENEWAL OF A GRANT OR CONTRACT IF15THE EXTENSION OR RENEWAL WAS AWARDED ON OR AFTER OCTOBER 1, 2018.

[(b)] (C) If a nonprofit organization is a direct recipient or subrecipient of a grant or contract for the provision of services that is funded wholly with State funds or with a combination of State and other nonfederal funds, the terms of the grant or contract shall allow for reimbursement of indirect costs:

4 [(c) This section applies whether or not the funds awarded through the grant or 5 contract are transferred directly by the State or through a third party to the nonprofit 6 organization.]

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
 1, 2019.
