A BILL ENTITLED

1 AN ACT concerning

2 **State Board of Education – Financial Literacy Curriculum – Graduation**
3 **Requirement**

4 FOR the purpose of requiring the State Board of Education to develop curriculum content
5 for a certain course in financial literacy; requiring each county board of education to
6 implement the financial literacy curriculum content developed by the State Board in
7 certain high schools; requiring students to complete a certain course in order to
8 graduate from high school; and generally relating to the development and
9 implementation of a course in financial literacy that is required for graduation from
10 a public high school in the State.

14 Annotated Code of Maryland

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Education**

19 **7–205.5.**

20 **(A) THE STATE BOARD SHALL DEVELOP CURRICULUM CONTENT FOR A**
21 **HALF–SEMESTER–LONG COURSE IN FINANCIAL LITERACY.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

1 **(B) EACH COUNTY BOARD SHALL IMPLEMENT THE FINANCIAL LITERACY**
2 **CURRICULUM CONTENT DEVELOPED BY THE STATE BOARD UNDER SUBSECTION (A)**
3 **OF THIS SECTION IN EVERY HIGH SCHOOL IN THE COUNTY.**

4 **(C) IN ORDER TO GRADUATE FROM HIGH SCHOOL, A STUDENT SHALL**
5 **COMPLETE A COURSE IN FINANCIAL LITERACY.**

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
7 1, 2019.
