A BILL ENTITLED

1 AN ACT concerning

Harford County – Alcoholic Beverages – Class DBR License

3 FOR the purpose of establishing a Class DBR license in Harford County; authorizing the 4 Board of License Commissioners to issue a Class DBR license to a holder of a Class $\mathbf{5}$ 5 manufacturer's (brewery) license; providing that a Class DBR license serves as a 6 certain permit and license specified under a certain provision of law; specifying that a holder of a Class DBR license is not required to sell food; authorizing the holder of 7 8 a Class DBR license to sell a certain amount of beer for on-premises consumption; 9 prohibiting a holder of a Class DBR license from selling beer for off-premises consumption other than a certain amount; specifying that the value of certain 1011 equipment may be used toward meeting a certain requirement; providing for the 12hours of sale and an annual license fee; and generally relating to alcoholic beverages in Harford County. 13

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

Article 2B – Alcoholic Beverages

22 **3–402.**

(A) THIS SECTION APPLIES ONLY IN HARFORD COUNTY.

24 (B) THERE IS A CLASS DBR LICENSE.

1 (C) (1) THE BOARD OF LICENSE COMMISSIONERS MAY ISSUE A CLASS 2 DBR LICENSE TO A HOLDER OF A CLASS 5 MANUFACTURER'S (BREWERY) LICENSE.

3 (2) A CLASS DBR LICENSE SERVES AS THE ON-SITE CONSUMPTION 4 PERMIT AND THE LICENSE EQUIVALENT TO A CLASS D LICENSE SPECIFIED UNDER 5 § 2–206(B)(2)(I) AND (III) OF THIS ARTICLE.

6 (3) A HOLDER OF A CLASS DBR LICENSE IS NOT REQUIRED TO SELL 7 FOOD.

8 (D) A HOLDER OF A CLASS DBR LICENSE:

9 (1) MAY SELL BEER BREWED AT THE BREWERY NOT EXCEEDING 500 10 BARRELS PER YEAR FOR ON-PREMISES CONSUMPTION; BUT

11 (2) MAY NOT SELL ANY BEER FOR OFF-PREMISES CONSUMPTION 12 OTHER THAN WHAT IS ALLOWED UNDER THE LICENSE HOLDER'S CLASS 5 13 MANUFACTURER'S (BREWERY) LICENSE.

14 **(E)** THE VALUE OF THE EQUIPMENT USED ON THE PREMISES MAY BE USED 15 TOWARD MEETING ANY MINIMUM CAPITAL INVESTMENT REQUIREMENT IMPOSED 16 ON A HOLDER OF A CLASS DBR LICENSE.

17 (F) THE HOURS OF SALE ARE AS PROVIDED UNDER § 11–513 OF THIS 18 ARTICLE.

19 (G) THE ANNUAL LICENSE FEE IS \$500.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 21 1, 2015.
