Prince George's County – Elementary School Students – Daily Physical Activity (Student Health and Fitness Act)

4 FOR the purpose of requiring that a public school student in a Prince George's County 5 elementary school be provided a certain daily program of physical activity each week 6 totaling a minimum number of minutes; requiring the program of physical activity 7 for a certain category of student to be consistent with a certain program for the 8 student, if applicable; requiring a Prince George's County public elementary school 9 to designate a certain group to plan and coordinate certain activities; requiring the Prince George's County Board of Education to adopt certain regulations; requiring a 10 11 certain elementary school to provide a certain notice to the county board on or before 12 a certain date; authorizing a public elementary school to apply to the county board 13 for a certain extension; establishing the termination date of a certain extension; and 14 generally relating to elementary school student health and fitness in Prince George's 15 County.

21 Preamble

WHEREAS, Obesity leads to at least 300,000 deaths among adults in the United States each year due in part to physical inactivity and a poor diet; and

WHEREAS, Inadequate participation in physical activity is a significant contributor to the "epidemic of obesity" that has plagued the nation's young people during the past 2 decades; and

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



WHEREAS, Physical activity offers young people many health benefits, including improving aerobic endurance and muscular strength, helping to control weight, building lean muscle and reducing fat, and helping to build greater bone mass, all of which thwart the development of osteoporosis in adulthood and prevent or reduce high blood pressure; and

WHEREAS, A growing body of evidence suggests that providing students with more physical education and physical activity opportunities helps reduce the cost schools incur by reducing absenteeism, improving student health, and reducing staff time spent addressing academic performance; and

- WHEREAS, A growing body of evidence also suggests that improvement in test scores and overall academic achievement can be linked to increased time in physical education; and
- WHEREAS, The National PTA considers "Early Physical Education" a "Parent Priority" and urges its members to promote physical education in the schools; now, therefore,
- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 17 That the Laws of Maryland read as follows:
- 18 Article Education
- 19 **7–409.1.**
- 20 (A) THIS SECTION APPLIES ONLY IN PRINCE GEORGE'S COUNTY.
- (B) (1) (I) A STUDENT IN PUBLIC ELEMENTARY SCHOOL IN PRINCE GEORGE'S COUNTY SHALL BE PROVIDED A DAILY PROGRAM OF PHYSICAL ACTIVITY TOTALING 150 MINUTES EACH WEEK, INCLUDING A MINIMUM OF 90 MINUTES OF PHYSICAL EDUCATION.
- 25 (II) ANY MINUTES NOT CONSISTING OF PHYSICAL EDUCATION 26 SHALL CONSIST OF DEVELOPMENTALLY APPROPRIATE, MODERATE—TO—VIGOROUS 27 ACTIVITY, INCLUDING RECESS.
- 28 (2) A STUDENT'S PROGRAM OF PHYSICAL ACTIVITY SHALL BE 29 CONSISTENT WITH THE STUDENT'S INDIVIDUALIZED EDUCATION PROGRAM, IF 30 APPLICABLE.
- 31 (3) EACH PUBLIC ELEMENTARY SCHOOL IN PRINCE GEORGE'S
 32 COUNTY SHALL DESIGNATE A PHYSICAL ACTIVITY LEADERSHIP TEAM TO PLAN AND
 33 COORDINATE OPPORTUNITIES FOR ACTIVITIES THAT MEET THE REQUIREMENTS OF
 34 PARAGRAPH (1)(II) OF THIS SUBSECTION.

- 1 (4) THE PRINCE GEORGE'S COUNTY BOARD OF EDUCATION SHALL 2 ADOPT REGULATIONS TO IMPLEMENT THIS SUBSECTION.
- 3 (C) (1) A PUBLIC ELEMENTARY SCHOOL THAT DOES NOT MEET THE 4 REQUIREMENTS OF THIS SECTION SHALL NOTIFY THE PRINCE GEORGE'S COUNTY BOARD OF EDUCATION ON OR BEFORE OCTOBER 1, 2020.
- 6 (2) A PUBLIC ELEMENTARY SCHOOL MAY APPLY TO THE PRINCE GEORGE'S COUNTY BOARD OF EDUCATION FOR AN EXTENSION OF TIME FOR THE PUBLIC ELEMENTARY SCHOOL TO ESTABLISH A PLAN TO ENSURE FULL COMPLIANCE WITH THE REQUIREMENTS OF THIS SECTION BY JULY 1, 2023.
- 10 (3) IF GRANTED, AN EXTENSION SHALL TERMINATE AT THE END OF 11 JULY 1, 2023.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 13 1, 2020.
